

U.S. Agricultural Trade Update

Summary—U.S. agricultural exports for January–December 1999 were \$48.3 billion, 7 percent and \$3.5 billion below 1998's value. Imports for the same period were \$38 billion, an increase of \$800 million. This brings the U.S. trade surplus down from \$14.8 billion in 1998 to \$10.3 billion in calendar 1999, the smallest surplus in the past decade.

Exports of \$4.4 billion in December were more than \$220 million lower than the previous month. In contrast, imports were up \$182 million, which brings the December trade surplus down to \$1 billion from \$1.3 billion the previous month.

Exports—More than half of the \$3.5-billion decline in total export value in calendar 1999 was due to lower bulk commodity exports, which declined by almost \$2 billion from 1998. High-value exports, which were almost twice as large as bulk exports in 1999, fell 5 percent, or by \$1.6 billion. Cotton exports, in value and volume, declined the most among bulk commodities, and only corn gained from 1998.

With the largest export value among bulk commodities, corn shipments amounted to almost \$5 billion in calendar 1999, a gain of \$500 million from 1998. Volume shipments were 52 million metric tons (mmt), up almost 11 mmt. The larger percentage rise in export volume than value reflects the 11-percent decline in corn prices from 1998. Corn prices at U.S. Gulf ports averaged \$2.29 per bushel in 1999, the lowest since they fell below \$2 in 1987. Most export gains were in Egypt, South Korea, and Taiwan.

Soybean exports of \$4.5 billion in 1999 are the next largest in sales among bulk commodities. This value, however, is \$318 million less than in 1998 despite a 14-percent rise in volume shipments to 23 mmt. A \$45 drop in price per metric ton from 1998 is the reason for the lower export value. The \$200 average price per metric ton in 1999 is the lowest over the past two decades. Export gains were largest in Taiwan and Southeast Asia.

Wheat exports in 1999 were valued at more than \$3.5 billion, a 4-percent fall from 1998. Because volume shipments of 28 mmt were up 5 percent, lower wheat prices were responsible for the decline in value. The average price for wheat was only \$3.05 per bushel in 1999, 11 percent below 1998 prices, and equaled 1987 prices. The only major market where exports

increased was Russia, the principal recipient of U.S. food aid last year.

Exports of cotton totaled less than \$1 billion in 1999, in sharp contrast to more than \$2.5 billion in 1998. The drop in cotton export value is attributed only in part to lower export prices. Cotton prices in 1999 were the lowest since 1986, and 21 percent below 1998 prices. The primary reasons for the export drop include the 25-percent fall in U.S. production due to drought, the suspension of Step 2 payments to U.S. cotton farmers, and competition from China. Unlike the other bulk exports, the volume of cotton shipments also fell—by over 900,000 metric tons.

Exports of *high-value products* decreased in value from 1998. While the 5-percent decline is only half the 10-percent fall in bulk export value, the earnings declines are not much different. By far, poultry exports registered the largest retreat in value, followed by nuts, feeds, and hides. Lower worldwide demand due to currency devaluations is partly responsible. Asia, Latin America, and Europe shared almost equally in lower U.S. sales. Red meats posted the largest export gains (up \$311 million), followed by vegetables (up \$75 million), then sugar (up \$50 million).

Imports—The 2-percent rise in imports over 1998 were from competitive products, including red meats (up \$400 million), grains (up \$144 million), fruits and juices (up \$570 million), nuts (up \$130 million), vegetables (up \$208 million), and beverages (up \$560 million). The almost \$800-million increase in total imports in 1999 is attributed to the 4-percent growth of the U.S. economy and the dollar's high exchange value. Import gains were largest from Brazil, followed by Canada, Mexico, Chile, India, and Australia.

Exports boost the U.S. economy.

Production from more than a third of U.S. cropland moved into export channels. Each dollar in agricultural export earnings in 1998 generated another \$1.30 in supporting activities for a total of \$120 billion (see report and table 5). An estimated 808,000 full-time jobs, including 488,000 in the nonfarm sector, were related to agricultural exports in 1998.




U.S. Agricultural Trade Boosts Overall Economy

Production from more than a third of U.S. cropland moved into export channels. U.S. agricultural exports generate employment, income, and purchasing power in both the farm and nonfarm sectors of the economy. Each dollar received from agricultural exports in calendar year 1998 stimulated another \$1.30 in supporting activities. The \$51.8 billion of agricultural exports in 1998 stimulated an additional \$67.9 billion of output. Exports thus generated \$119.7 billion in business activity in 1998.

Agricultural exports created an estimated 808,000 full-time civilian jobs, including 488,000 jobs in the nonfarm sector. Farmers' purchases of fuel, fertilizer, and other inputs to produce commodities for export also spurred economic activity in the manufacturing, trade, and transportation sectors. Net agricultural exports in 1998 reduced the merchandise trade deficit by \$14.8 billion, a decline from \$21 billion in 1997.

Exports Generate New Business, Add Jobs

The \$51.8 billion of U.S. agricultural exports in calendar 1998 consisted of \$18.3 billion of raw commodities, \$22.5 billion of processed products, and \$11.1 billion of transportation and trade services for the raw and processed exports. The \$67.9 billion worth of supporting activity included \$14.2 billion from the farm sector, \$5.7 billion from the food processing sector, \$15.1 billion from other manufacturing sectors, \$10.8 billion from trade and transportation, and \$22.1 billion from other services. The farm sector accounted for about 21 percent of the overall gains to the economy.

Employment needed to support 1998's agricultural exports decreased slightly from 1997 as exports fell. Factors such as the commodity mix, sectoral price changes, and the actual volume of goods contributed to the employment drop. Of the 808,000 full-time civilian jobs related to agricultural exports, more than 320,000 were farm workers. Almost 10 percent of farm labor was employed in the production of export commodities. In addition, 488,000 jobs in the nonfarm sector were involved in assembling, processing, and distributing agricultural products for export. About 78,000 of these workers were in food processing, 155,000 in trade and transportation, 65,000 in other manufacturing sectors, and 190,000 in other services.

The value of bulk agricultural exports (grains, oilseeds, and cotton) declined by about \$4.1 billion in 1998. Non-bulk exports (fresh fruits and vegetables, semi-processed, and high-value processed) decreased by \$1.3 billion from 1997. High-value agricultural exports accounted for \$32.3 billion, or 62 percent, of exports. Bulk exports have a smaller proportional effect on the nonfarm economy than processed exports. Bulk exports generated an additional \$17.9 billion of business activity, while nonbulk exports generated an additional \$50 billion.

The additional business activity attributed to bulk exports was distributed across economic sectors--4 percent in farming, 29 percent in manufacturing, 50 percent in other services, and 17 percent in wholesale and retail trade and transportation. Additional business activity from high-value agricultural exports include 27 percent in farming, 31 percent in manufacturing, 26 percent in other services, and 16 percent in wholesale and retail trade and transportation. Of the 808,000 jobs related to U.S. agricultural exports, 478,000, or 59 percent, supported nonbulk exports.

The farm sector received 27 percent of total income from agricultural exports in 1998, while the food processing sector received 12 percent, reflecting the relative importance of raw agricultural commodities in export earnings.

The Effect of Agricultural Imports on U.S. Output

Net agricultural exports of \$14.7 billion partially offset the \$288 billion deficit in nonfarm trade in 1998, leaving the U.S. trade balance in deficit by \$274 billion. The United States imported \$37.1 billion of agricultural commodities in calendar 1998; \$9 billion of which was spent on items such as bananas, coffee, and tea that do not compete against U.S. products. The balance of \$28.1 billion was spent on imports (such as meat, dairy products, fruits, nuts, vegetables, sugar, and wines) that compete with U.S. products. We estimated that the equivalent domestic output effect of the \$28.1 billion of competitive imports in 1998

was \$66.7 billion. Each dollar spent on imports would have required another \$1.37 in supporting goods and services if those imported items had been produced domestically, an output multiplier of 2.37.

Most of the agricultural trade surplus is attributed to bulk exports. The \$33.1 billion of nonbulk exports almost offsets the \$37.1 billion of total imports. The economywide net business surplus in 1998 with respect to agricultural trade was an estimated \$44 billion, resulting from \$119.7 billion of total output generated by farm exports minus \$75.7 billion stimulated by agricultural imports, including noncompetitive imports.

U.S. agricultural trade positively affects most sectors of the economy. The farm sector's \$32.5 billion of output associated with agricultural exports is more than double the \$16.2 billion of farm output displaced by competitive agricultural imports in 1998. Total manufacturing production, including food processing, increased \$16.6 billion, accounting for 65,000 jobs and \$4.2 billion in income. The U.S. economy gained a net output of \$29.3 billion after subtracting output lost to competitive agricultural imports. Outside of farming and food processing, the U.S. economy gained a net \$6.4 billion from agricultural trade.
