CATTLE ON FEED IN 13 QUARTERLY STATES UP 7 PERCENT

Cattle and Calves on Feed January 1, 1985, for the slaughter market in 13 quarterly States totaled 10.6 million head, 7 percent more than the previous year and 4 percent above 1983, according to the Crop Reporting Board.

The total feedlot inventory included 6.76 million steers and steer calves, up 4 percent from 1984 and 2 percent above the January 1, 1983 number. This group represented 64 percent of the total number on feed compared with 66 percent on January 1, 1984. Heifers and heifer calves accounted for 3.83 million head, up 14 percent from last year and 8 percent above 1983.

Placements of cattle and calves on feed during the October - December quarter totaled 7.56 million head, 4 percent greater than the same quarter in 1983 and 5 percent more than the fourth quarter total in 1982. Other Disappearance of 417 thousand head leaves Net Placements for the October - December quarter of 1984 at 7.14 million.

Marketings of fed cattle for slaughter during October - December 1984 totaled 5.51 million head, an increase of 1 percent from fourth quarter marketings in 1983 and 2 percent above marketings in 1982.

EXPECTED MARKETINGS FOR JANUARY - MARCH UP 6 PERCENT

During the first quarter of 1985, 6.07 million head of fed cattle are expected to be marketed. This would be a 6 percent increase from first quarter marketings in 1984 and 7 percent above 1983.

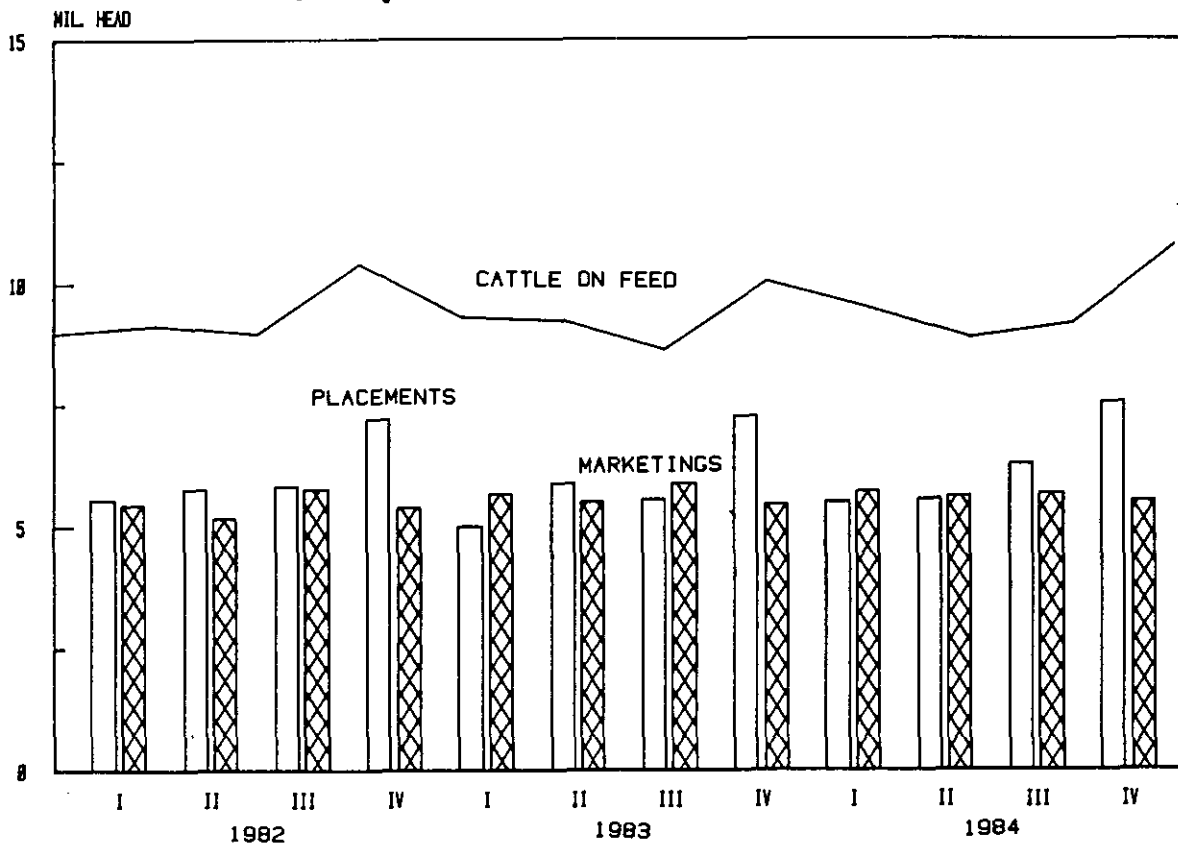
CATTLE ON FEED IN 7 MONTHLY STATES UP 8 PERCENT

The number of cattle and calves on feed January 1, 1985, in the 7 monthly States was 8.62 million head, 8 percent above last year and 4 percent higher than 1983. Feedlot numbers were up 18 and 16 percent in Texas and Kansas, respectively. Placements during December of 1.62 million head were down 8 percent from 1983. Marketings during December 1984 totaled 1.41 million head, down 2 percent from 1983. Other Disappearance in December amounted to 137 thousand head compared with 119 thousand in 1983.

The October - December Quarterly Marketings in the 7 States totaled 4.57 million head, 1 percent more than the previous year and 3 percent greater than the same quarter in 1982. Marketings in the 7 States during the October - December quarter accounted for 83 percent of the 13-State total. Expected Marketings in the 7 States during January - March 1985 are 5.07 million head, up 6 percent from the same quarter in 1984 and 7 percent above 1983 marketings.
