CATTLE ON FEED UP 9 PERCENT IN 13 QUARTERLY STATES

Cattle and calves on feed July 1, 1987 for slaughter in the 13 Quarterly States totaled 8.67 million head, up 9 percent from July 1 last year but unchanged from 1985, according to the Agricultural Statistics Board.

The cattle on feed inventory included 5.60 million steers and steer calves, 14 percent above last year and 7 percent above 1985. This group represented 65 percent of the total July number on feed compared with 62 percent in 1986. Heifers and heifer calves accounted for 3.03 million, virtually unchanged from a year ago but 10 percent below April 1, 1985.

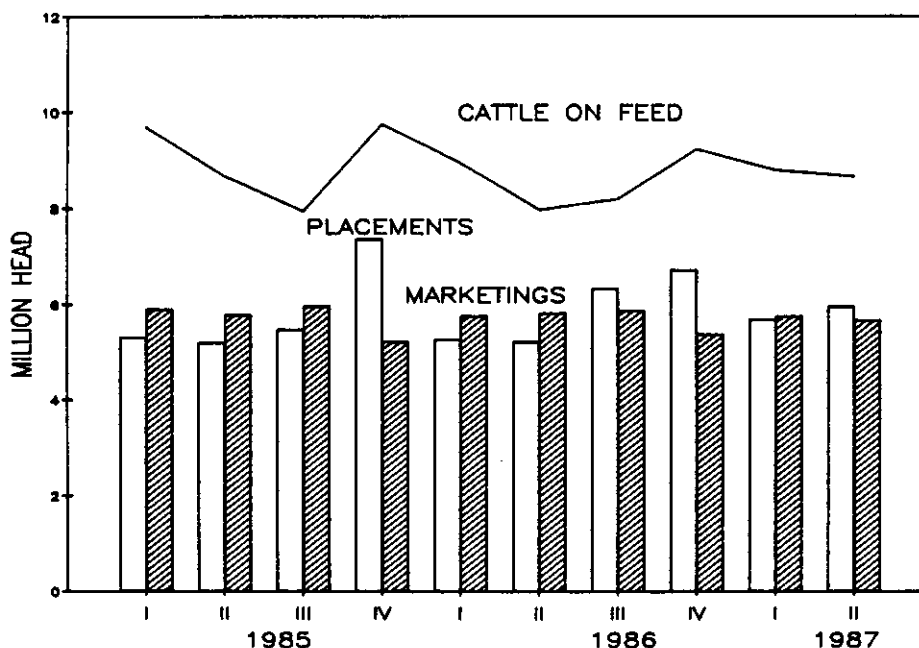
PLACEMENTS of cattle and calves on feed during the April-June quarter totaled 5.96 million, up 14 percent from last year and 15 percent above the comparable period in 1985. OTHER DISAPPEARANCE of 423 thousand head leaves NET PLACEMENTS at 5.54 million.

MARKETINGS of fed cattle for slaughter during April-June totaled 5.67 million, 3 percent less than a year ago and 2 percent below 1985.

EXPECTED MARKETINGS FOR JULY-SEPTEMBER UP 4 PERCENT

Cattle feeders expect to market 6.12 million head during the July-September quarter of 1987. This would be 4 percent more than the third quarter marketings in 1986 and 2 percent more than in 1985.

CATTLE ON FEED IN 7 MONTHLY STATES UP 10 PERCENT

Cattle on feed July 1, 1987 in the 7 monthly States totaled 7.19 million, 10 percent more than the previous year, and 2 percent more than two years ago. PLACEMENTS in feedlots during June totaled 1.46 million, 26 percent above last year and 15 percent above 1985. MARKETINGS during June totaled 1.70 million, 3 percent more than in 1986 and 8 percent above 1985. OTHER DISAPPEARANCE during June was 87 thousand head, 30 percent above last year but unchanged from 1985.

The APRIL-JUNE QUARTERLY MARKETINGS for the 7 States, at 4.81 million were down 2 percent from last year but about the same as 1985. Marketings for the 7 States during the April-June quarter accounted for 85 percent of the 13-State total. EXPECTED 7-STATE MARKETINGS for the July-September 1987 quarter are estimated at 5.16 million, up 3 percent from the corresponding quarter of 1986 and 4 percent above 1985.
