CATTLE ON FEED IN 7 STATES DOWN 4 PERCENT FROM LAST YEAR

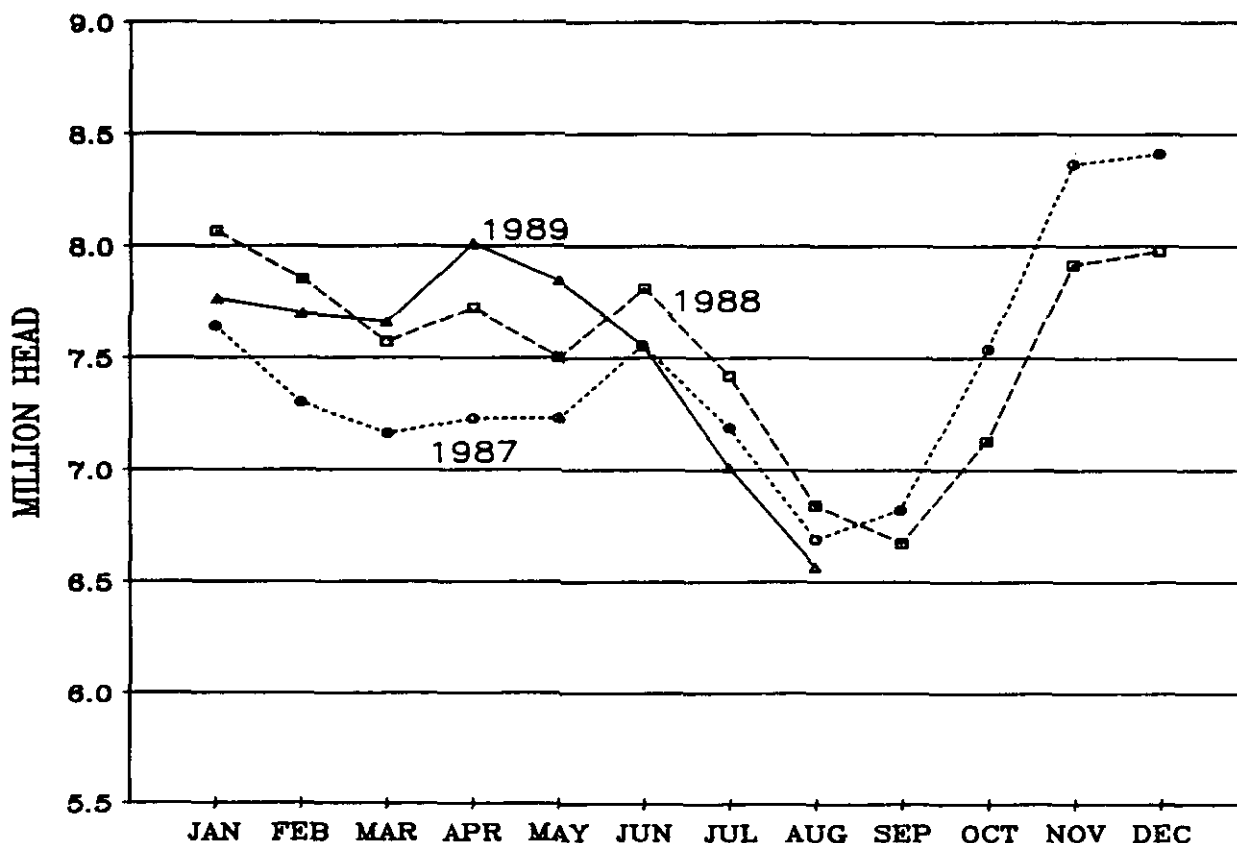
Cattle and calves on feed August 1, 1989, for slaughter market in the 7 States preparing monthly estimates totaled 6.57 million head, down 4 percent from a year ago and 2 percent below August 1, 1987, according to the Agricultural Statistics Board.

MARKETINGS of fed cattle during July totaled 1.69 million, down 4 percent from last year and 1 percent below two years ago.

PLACEMENTS of cattle and calves on feed in the 7 States during July totaled 1.31 million, up 5 percent from last year and 3 percent above July 1987. NET PLACEMENTS of 1.25 million for JULY is 5 percent above last year and 4 percent above 1987.

OTHER DISAPPEARANCE totaled 63.0 thousand head compared to 62.0 thousand in July 1988 and 71.0 thousand in July 1987.
