## Bureau of the Census Cotton Information

Cotton consumed during the month ending August 31, 1997, amounted to 868,874 bales. Cotton on hand in consuming establishments at the end of August was 661,667 bales, and the total in public storage and compresses was 2,387,496 bales. Active consuming cotton spindles totaled 2,613,000, and the quantity of domestic cotton exported, excluding linters, was 399,100 bales. These and other data were published in "Census Bulletin M22P(97)-8", dated September 23, 1997.

The next "Cotton Ginnings" report will be released at 8:30 a.m. ET on October 24, 1997.
