FARM WAGE RATES UP SMALLER FORCE MEETS SEPTEMBER WORK DEMANDS

Farmers across the Nation on October 1 were paying for hired farm work at wage rates averaging almost 4 percent higher than last year, according to the Crop Reporting Board. Wage rates without board or room averaged 99 cents per hour, and showed the usual large State differences, ranging from 57 cents per hour in South Carolina to a high of \$1.42 per hour in Connecticut. The composite hourly wage rate reflecting cash payments for all specified hiring arrangements averaged 89.8 cents per hour--up about 4 percent from the average of 86.8 cents on October 1, 1962. The index of the composite average rate on October 1 was 681 percent of the 1910-14 base period. Much of the influence of the rate increases over this long period has been offset by reduced labor use. However, despite the increased use of machines and changed methods to improve work efficiency, costs of hired farm labor remain an important part of total farm production costs. The index of prices paid by farmers for production items reported for September 15 was 273 percent of the 1910-14 base, and the index of prices received by farmers on the same basis was 241.

The wage rates shown by States on pages 6 and 7 are cash rates paid on farms of reporters or in their home localities for the hiring arrangements specified and do not include the value of housing, food, or other items furnished as part of total wages.

Farm Worker Numbers at New September Low

A total of 8,190,000 persons were working on farms during the farm labor survey week of September 22-28. This was 2 percent less than a year earlier and the smallest number of record for the date. Farm operators and other unaid family members totaled 5,526,000--3 percent less than last year's total for the date.

The number of hired farm workers in late September edged above last year's level and totaled 2,664,000 persons. More than half of these were employed in South Central and South Atlantic States. Increases in the number of hired workers over a year earlier were most significant in the South Atlantic and East South Central regions as shown by comparisons on page 4.

Generally favorable weather for field work in September pushed cotton harvest in the South. Fruit and vegetable harvests were at peak levels in

important areas in Pacific Coast States and in the Northeast. Tobacco marketing preparations claimed many workers in Kentucky and North Carolina. And the Eastern peanut crop was being dug and picked. Corn harvest for grain was active in the coastal areas of South Atlantic States as all available pickers were kept in operation to get crops in ahead of those threatening hurricanes of 1963 named Edith and Flora by the Weather Bureau. Throughout the northern areas corn silage harvest was hurriedly completed to avert freeze loss. Much progress was made in seeding fall grains in the Great Plains, and in other important grain-producing areas.

Cotton Harvest Brings White Flood to Gins

In the land of cotton late September usually is picking time with large increases in seasonal or short-term farm labor. Last year machines harvested more of the crop than ever before, reducing, somewhat, the number of workers between the cotton rows. Even so, about 30 percent of the Nation's seasonal hired workers at mid-September last year were harvesting cotton. This year, despite further increases in the machine harvest, hand picking still was an important southern farm job. The work was moving fast. By the end of September a total of 4,774,000 bales had been ginned, according to the Bureau of the Census, or 2 percent more than last year at the same date. The Crop Reporting Board estimated cotton production at 14,847,000 bales from a record high average yield per acre as of October 1, an increase of 4 percent from the September estimate, reflecting favorable developments for the crop during the month.

At the end of September the harvest was 70 percent completed in Georgia and more than half finished in South Carolina and Alabama. Nearly a third of the large crops in Mississippi, Arkansas, and Tennessee, and 35 percent of the Texas crop had been picked. In many localities all ginning facilities were flooded with cotton. The New Mexico harvest started earlier than last year, but little had been harvested in Arizona and California by the end of September.

Few Dull Moments for Farm Family Workers

Many varying kinds of work are reported in the wide range of conditions affecting the Nation's farms. The Maine potato harvest moved into high gear during the third week of September. Grape harvest started in New York, Pennsylvania, and Michigan. Harvest of soybeans was active throughout the Midwestern Soybelt and reached over two-thirds completion in Illinois, the State with largest acreage. Fall wheat drilling was two-thirds completed in the Texas High Plains, over half finished in Kansas, and approaching that mark in Oklahoma. Livestock movement from high summer ranges added interest to ranch affairs in Mountain States.
