Trend Toward Smaller Work Force and Higher Wage Rates Continues

The trend toward fewer workers on the Nation's farms continued through December 1965. During the December 19-25 survey week, a total of 4,210,000 persons made up the farm work force. This was 3 percent fewer workers than for the same period a year earlier and a record low for the month. Effects of the holiday season and normal winter slowdown are apparent when the December total is compared with the 1965 peak of over 6.8 million workers doing farm work during the June survey week.

Farm operators and family members working without wages on home farms during the week of December 19-25 numbered 3,438,000 persons - 4 percent under the comparable week in 1964 and 12 percent lower than a month earlier.

The number of hired farm workers in December reached a new low of 772,000. This was 2 percent fewer workers than in the comparable week a year earlier and nearly a third less than in November 1965.

The effects of mechanical harvesters and other labor saving devices for harvesting numerous vegetable and field crops are evident when the annual average numbers of workers in 1965 are compared with 1964 and the five year average. The 1965 annual average number of all workers is 8 percent lower than 1964 and 19 percent below the 5 year average. Since the use of foreign workers has been restricted by the repeal of Public Law 78, the need for and use of mechanical harvesters have increased considerably. Although the number of workers on farms during 1965 was at a record low, a new high was set in total crop production. The effect of lower acreages for many crops was offset by record yields per acre. The all crop production index of 117 (1957-59=100) for 1965 is 6 percent higher than the previous year and 4 percent above the previous high in 1963.

Seasonal Decline of Hours Per Worker Continues

Harvesting operations were complete on many farms and the primary concern was routine chores and caring for livestock. As a result the average number of hours worked per person on reporting farms during the December survey week declined from a month earlier in all regions. Farm operators averaged a work week of 36.3 hours, down 4.9 hours from November 1965. Other family workers averaged 29.2 hours, a drop of 1.2 hours.

Hired farm workers averaged 30.2 hours of farm work during the survey week. This was 2.8 fewer hours than during the November survey week. All farm workers averaged a work week of 33.7 hours compared with 36.6 hours the previous month.

Wage Rates Reach New Levels in 1965

Farm wage rates have been increasing consistently; during 1965 they increased more than in recent years. The 1965 annual composite hourly rate, reflecting cash payments for all hiring arrangements, averaged 95.1 cents, an increase of 5 percent over 1964. A year-to-year advance of 5 percent has been recorded in only one year since 1951-52 when pressures of the Korean war contributed to considerable increases. The annual average wage rates produced by weighting the quarterly reports are shown by States on pages 9 and 10.

The U.S. rate per hour without board or room averaged \$1.14 in 1965. This is an increase of 6 percent over the previous year. Wage rates for other principal hiring arrangements made similar advances in 1965.

Wage rates at the beginning of 1966 continued the upward trend. The January 1 composite hourly rate, at \$1.06, was 5 percent higher than for the same date in 1965.

All rates reported are from the Department's crop and livestock reporters and represent rates paid in their localities or on their own farms. Cash payments only are included with no allowances for values of housing, food, or other items included in total wages.

Christmas Season Slowed Farm Activities During Survey Week

As another Christmas season drew nigh, the pace of farm activities slowed as farmers and their families paused to celebrate the Yuletide season. On many farms across the country, adverse weather limited farm work to the routine chores of caring for livestock and poultry.

Cotton growers set a new record high for yield per acre in 1965. The indicated yield of 531 pounds per acre for the United States was 14 pounds above the previous high set in 1964 and 67 pounds above the 1959-63 average. The 1965 crop is estimated at 15,059,000 bales, down slightly from the previous year's production of 15,180,000 bales. Growers planted an estimated 14,152,000 acres, about 5 percent less than in 1964. The holiday season brought harvest to a close in most producing States east of the Mississippi. Harvest was at a standstill during the survey week in Arizona and California; limited progress was made in New Mexico and Texas as weather permitted.

Pruning and dormant spraying of California fruit and grape plantings continued, but at a slower pace because of adverse weather. Navel orange picking was also at a low ebb. Grapefruit harvest was increasing in the Desert Valley area. Total production of citrus fruits for the 1965-66 season, as of December 1, was forecast at 7 percent above last season and 10 percent above average. Production is expected to exceed both last year's and the average for oranges, grapefruit, and tangelos.

Tung nut harvest continued to make progress in Florida where production is expected to total 24,000 tons, about 70 percent of the estimated United States production of 34,200 tons. In Mississippi, production at 7,000 tons was less than 10 percent of the 1964 State crop of 79,500 tons. The Louisiana crop totaled 21,600 tons in 1964, but only 2,000 tons are expected from the 1965 crop. Freezes in March killed most of the buds and accounted for much of the crop reduction in both Mississippi and Louisiana; however, winds from hurricane Betsy destroyed additional nuts and some trees.

Sugarcane harvest in Louisiana was practically halted as a result of heavy rains December 17-19. About 90 percent of the crop had been harvested. A large part of the Louisiana crop was flattened by hurricane Betsy in early September; however, favorable weather following the hurricane permitted good recovery. Hurricane damage to the Florida crop was slight. Florida and Louisiana production is expected to total 12,412,000 tons, about 10 percent lower than the 1964 crop, but about 36 percent higher than the 1959-63 average for these States.

Burley tobacco stripping in Kentucky was limited by dry weather; therefore deliveries to warehouses in preparation for the reopening of markets on January 3rd were light. In South Carolina some progress was made in treating and preparing tobacco beds for seeding. The 1965 tobacco crop was harvested from about 977,500 acres, the smallest acreage since 1891. Total production is estimated at 1,913 million pounds, 14 percent below the 1964 crop and 9 percent lower than the 1959-63 average. The average yield of 1,957 pounds per acre was below the record 2,067 pounds in 1964, but was well above the average yield of 1,780 pounds.
