GRAIN STOCKS LOWER THAN A YEAR EARLIER

Stocks of all grains on October 1, 1973 were below a year ago, according to the Crop Reporting Board. Stocks of the four feed grains (corn, oats, barley, and sorghum) totaled 45.5 million tons, 26 percent less than holdings on October 1, 1972.

Stocks of all wheat were down 21 percent from a year earlier, while durum stocks were down 14 percent. Rye stocks were down 42 percent and the flaxseed level was 36 percent below last year.

Old crop corn stored in all positions on October 1 totaled 707 million bushels, 37 percent less than a year earlier. Corn stocks on farms, at nearly 403 million bushels, were 46 percent less than October 1 last year. Stocks in off-farm facilities, at 304 million bushels, were down 19 percent.

Disappearance from all positions during July-September 1973 totaled 1,224 million bushels of old crop corn, compared with 1,046 million during the same quarter last year.

Old crop sorghum grain on October 1, 1973 totaled 73 million bushels, 69 million bushels less than a year earlier and the lowest for the date since 1954. Farm and off-farm holdings, at 14 million and 59 million bushels, respectively, were both down sharply from a year earlier. Indicated disappearance of 128 million bushels from all storage locations during the July-September quarter was 4 percent less than the comparable total a year earlier.

As usual, estimates in this "Grain Stocks" report include grain stored on farms and grain located at off-farm storage facilities but exclude grain in transit as of the survey date. This report was formerly called "Stocks of Grains".

Oat holdings on October 1 totaled 845 million bushels, 9 percent below a year earlier. Comparable stocks of oats in all positions have been below the current inventory only twice, in 1966 and 1967, since this series of estimates began in 1943. Off-farm holdings of 200 million bushels were 20 percent below the previous year and compare with a record high of 281 million in 1971. Farm holdings, at 645 million bushels, were down 6 percent from a year earlier and were the lowest since 1934.

Disappearance during the July-September quarter was 269 million bushels, 11 percent below the same quarter in 1972. Exports were up sharply from a year earlier while domestic consumption was lower.

Barley stored in all positions on October 1 totaled 425 million bushels, 6 percent below a year earlier. Off-farm stocks of 138 million bushels were 4 percent above a year ago but farm stocks, at 287 million bushels, were 11 percent smaller. Disappearance during July-September was 167 million bushels, up 15 percent from the 145 million bushels a year ago.

All wheat in storage on October 1 totaled 1,475 million bushels, 21 percent less than a year earlier. Farm holdings, at 636 million, were down 12 percent from a year earlier, and off-farm stocks of 839 million bushels were down 26 percent from October 1, 1972. Disappearance from all storage positions during July-September was indicated at 681 million bushels, compared with 542 million bushels a year ago. Larger exports accounted for the increased disappearance.

Durum wheat stocks in all positions totaled 98.0 million bushels, 14 percent less than a year earlier and 26 percent below October 1, 1971. Both farm holdings of 77.0 million and off-farm stocks of 21.0 million were down 14 percent from last year. Disappearance during July-September 1973 amounted to 22.7 million bushels, compared with 28.1 million a year earlier.

Rye stocks in all storage positions on October 1 totaled 36.2 million bushels, down 42 percent from a year earlier and the lowest October 1 stocks since 1968. Off-farm stocks, at 22.0 million bushels, were 46 percent less than a year earlier and farm stocks were down 35 percent. Indicated disappearance during July-September was 22.7 million bushels, compared with 12.6 million a year earlier.

Flaxseed stocks totaled 14.0 million bushels on October 1, 1973, about one-third less than a year ago and the lowest October 1 total of record which dates back to 1947. Off-farm holdings, at 7.6 million bushels, were down from 15.4 million bushels a year earlier and accounted for this year's lower level. Farm holdings, at 6.4 million bushels, were up slightly (2 percent) from last year. July-September indicated disappearance, at 5.4 million bushels, was sharply lower than the comparable 12.3-million-bushel total last year. Reported disappearance for the quarter included about 5.0 million bushels crushed and 81,000 bushels exported.
