ALL WHEAT STOCKS HIGHER - OTHER GRAINS BELOW LAST YEAR

On October 1, 1974, stocks of all grains except all wheat were below a year ago, according to the Crop Reporting Board. Stocks of the four feed grains (corn, oats, barley, and sorghum) in all positions totaled 33.7 million tons, 25 percent less than holdings on October 1, 1973.

Stocks of all wheat were up 6 percent from a year earlier, while durum stocks were down 10 percent. Rye stocks were down 44 percent and flaxseed was 15 percent below last year.

Old crop corn stored in all positions on October 1 totaled 481 million bushels, 32 percent less than a year earlier and the lowest for this date since 1948. Corn stocks on farms, at 287 million bushels, were 29 percent less than October 1 last year. Stocks in off-farm facilities, at 195 million bushels, were down 36 percent.

Disappearance from all positions during July-September 1974 totaled 960 million bushels of old crop corn compared with 1,229 million during the same quarter last year.

Old crop sorghum grain on October 1, 1974 totaled 62 million bushels, 15 percent or 11 million bushels less than last year's low level and the lowest level for the date since 1954. Farm stocks at 18.5 million bushels were 34 percent more than last year. However, off-farm stocks at 43.1 million bushels were 27 percent less than a year earlier. Indicated disappearance at 118 million bushels from all storage positions during the July-September quarter was 7 percent less than during the comparable period last year.

Oats in storage October 1, 1974, totaled 677 million bushels, 16 percent less than a year earlier and the lowest for the date since records started in 1943. Off-farm stocks of 155 million bushels were 22 percent below last year. Farm holdings at 522 million bushels were down 14 percent from a year earlier and the lowest since 1934.

Disappearance during the July-September quarter was 226 million bushels, 16 percent below the same period last year. Exports were down sharply from last year with domestic consumption also lower.

Barley stored in all positions on October 1 totaled 321 million bushels, 24 percent below a year earlier. Off-farm stocks of 126 million bushels were down 8 percent from a year ago and farm stocks, at 194 million bushels, were down 32 percent. Disappearance during July-September was 124 million bushels, down 24 percent from the 163 million bushels a year ago.

All wheat in storage on October 1, 1974, totaled 1,546 million bushels. This quantity was 6 percent above a year earlier and compares with 1,870 million bushels on October 1, 1972. Off-farm stocks at 882 million bushels were up 5 percent from a year ago. Farm holdings as of October 1 accounted for 664 million bushels, an 8 percent increase over the previous year. Disappearance of stocks from all storage positions during July-September was indicated at 483 million bushels, compared with 693 million bushels for the comparable quarter last year.

Durum wheat stocks in all positions totaled 87.9 million bushels, 10 percent less than a year earlier and 24 percent below October 1, 1972. Farm holdings of 63.9 million bushels declined 16 percent from a year earlier while off-farm holdings were up 12 percent. Disappearance during July-September 1974 amounted to 19.6 million bushels compared with 24.5 million a year earlier.

Rye stocks in all storage positions on October 1 totaled 20.8 million bushels, down 44 percent from a year earlier and the lowest October 1 stocks since 1952. Off-farm stocks, at 9.0 million bushels, were 59 percent less than a year earlier and farm stocks were down 20 percent. Indicated disappearance during July-September was 9.8 million bushels, compared with 22.8 million a year earlier.

Flaxseed stocks totaled 11.9 million bushels on October 1, 1974, 2.1 million bushels less than a year earlier and the smallest October 1 stocks since records were started in 1947. On-farm stocks at 7.3 million bushels were 14 percent larger than last October's 6.4 million bushels. However, off-farm stocks at 4.6 million bushels were 40 percent below last year. July-September indicated disappearance at 5.2 million bushels was 12 percent less than last year's comparable period and less than half of the large disappearance two years ago. Reported disappearance for the quarter includes about 3.5 million bushels crushed and 26,000 bushels exported.
