CORN, AND SOYBEAN STOCKS DOWN FROM A YEAR AGO

ALL WHEAT STOCK UP

Corn stocks on June 1, 1981 totaled 70.5 million metric tons, down 24 percent from last year's record high level while soybean stocks, at 18.6 million metric tons, were down 12 percent, according to the Crop Reporting Board. Stocks of the four feed grains (corn, sorghum, barley and oats) totaled 80.7 million metric tons, 25 percent less than June 1, 1980. Changes from last year, in addition to corn and soybeans, were sorghum, down 33 percent; oats, down 25 percent; and barley, down 29 percent. All wheat stocks totaled 27.0 million metric tons, 10 percent above a year ago.

Corn stored in all positions on June 1, 1981 totaled 2.77 billion bushels (70.5 million metric tons), 24 percent below last year's level of 3.67 billion bushels (93.2 million metric tons). Farm stocks totaled 1.82 billion bushels (46.2 million metric tons), down 29 percent from the June 1 stocks a year earlier. Off-farm stocks at 956 million bushels (24.3 million metric tons) were off 13 percent from last year's level. Disappearance from all storage positions during April and May 1981 was 1.22 billion bushels (31.1 million metric tons), 3 percent more than the disappearance for the same period last year. Disappearance for the crop year to date (October 1, 1980-June 1, 1981) totaled 5.49 billion bushels (139 million metric tons), down 1 percent from the disappearance for the comparable period a year earlier. Exports are running 11 percent ahead of a year ago. Food, seed and industrial use is up 13 percent while feed and residual is down 9 percent. Of the total June 1, 1981 corn stored in all positions, 655 million bushels were under Government control. Of this amount, 240 million bushels were owned by the Commodity Credit Corporation and 415 million bushels were held in the farmer-owned reserve.

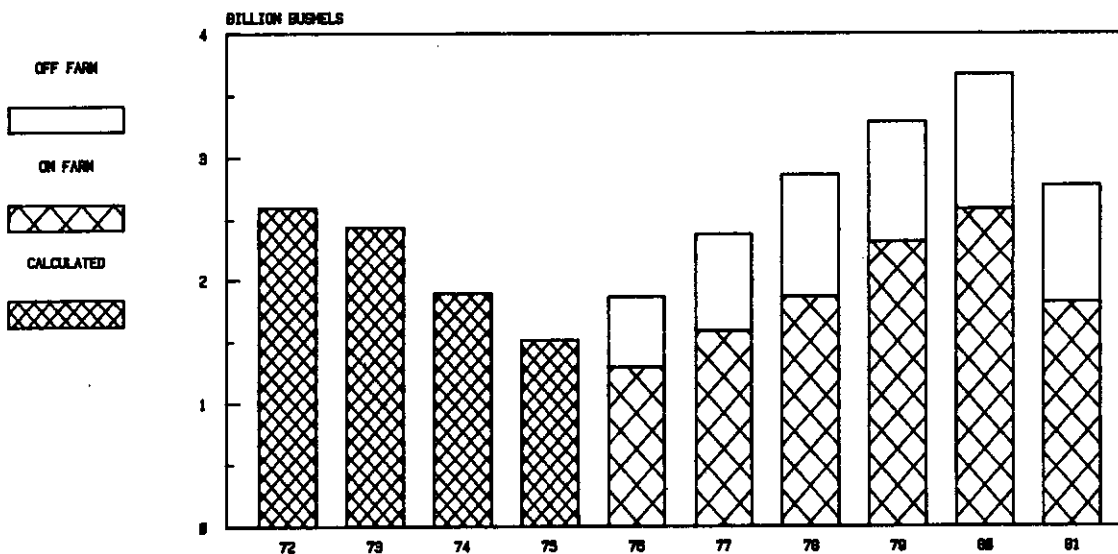
Sorghum in all positions on June 1, 1981 amounted to 185 million bushels (4.71 million metric tons), 33 percent less than a year earlier and 42 percent less than on June 1, 1979. Farm stocks totaled 52.0 million bushels (1.32 million metric tons), 43 percent less than last year and off-farm holdings, at 134 million bushels (3.39 million metric tons), were down 28 percent. Disappearance from all storage positions during April and May 1981 was 127 million bushels (3.24 million metric tons), up 8 percent from the disappearance of 118 million bushels (3.00 million metric tons) during the same period last year. Of the June 1, 1981 total sorghum stocks, 37.6 million bushels were under Government control. This total was owned by the Commodity Credit Corporation. There was no sorghum held in the farmer-owned reserve.

Old crop oat stocks in all storage positions on June 1, 1981 amounted to 176 million bushels (2.56 million metric tons), 25 percent less than a year earlier and 37 percent less than on the same date in 1979. Farm stocks, at 149 million bushels (2.16 million metric tons), were 25 percent below a year ago and off-farm stocks, at 27.8 million bushels (403 thousand metric tons), were 27 percent less than a year ago. Disappearance from all storage positions during April and May 1981 was 79.3 million bushels (1.15 million metric tons), 23 percent less than disappearance for the same period last year. Of the June 1 total oats stocks, 1.85 million bushels were under Government control--1.66 million bushels owned by the Commodity Credit Corporation and 187 thousand bushels held in the farmer-owned reserve.

Old crop barley stocks in all positions on June 1, 1981 totaled 137 million bushels (2.98 million metric tons), 29 percent less than last year's 192 million bushels (4.18 million metric tons), and 40 percent below June 1, 1979. Off-farm stocks, at 63.0 million bushels (1.37 million metric tons), were 21 percent less than last year and farm stocks, at 73.6 million bushels (1.60 million metric tons), were 34 percent below June 1, 1980. Indicated disappearance during April-May 1981 was 65.5 million bushels (1.43 million metric tons), 7 percent less than the corresponding period a year ago. Of the June 1 total barley stocks, 14.7 million bushels were under Government control--3.21 million bushels owned by the Commodity Credit Corporation and 11.5 million bushels held in the farmer-owned reserve.

Old crop wheat stored in all positions on June 1, 1981 amounted to 991 million bushels (27.0 million metric tons), 10 percent greater than the 902 million bushels (24.5 million metric tons) on hand a year earlier and 7 percent more than two years ago. Farm stocks totaled 414 million bushels (11.3 million metric tons), 42 percent of the total. In comparison, farm stocks last June 1 were 377 million bushels (10.2 million metric tons) which was also 42 percent of the total. June 1, 1981 off-farm stocks totaled 577 million bushels (15.7 million metric tons), 10 percent more than last year's 525 million bushels (14.3 million metric tons). April-May disappearance this year was 338 million bushels (9.21 million metric tons) compared with 323 million bushels (8.79 million metric tons) during the comparable period last year. June 1980-May 1981 disappearance totaled 2.28 billion bushels (62.1 million metric tons), 6 percent more than the 2.16 billion bushels (58.7 million metric tons) disappearance for a year earlier. Of the total June 1, 1981 old crop wheat stocks, 548 million bushels were under Government control. This total includes 189 million bushels owned by the Commodity Credit Corporation and 360 million bushels held in the farmer-owned reserve.

Old crop durum wheat stocks in all positions on June 1, 1981 at 60.8 million bushels (1.66 million metric tons) were about the same as last year's 61.0 million bushels (1.66 million metric tons) but 29 percent less than two years ago. Farm stocks accounted for 74 percent of the total or about 45.2 million bushels (1.23 million metric tons). June 1, 1980 farm stocks totaled 48.7 million bushels (1.32 million metric tons) or 80 percent of the total durum stocks. June 1, 1981 off-farm stocks totaled 15.7 million bushels (426 thousand metric tons) compared with 12.3 million bushels (336 thousand metric tons) last year. April-May disappearance this year totaled 22.4 million bushels (610 thousand metric tons); last year, April-May disappearance was 24.7 million bushels (673 thousand metric tons). June 1980-May 1981 disappearance totaled 109 million bushels (2.95 million metric tons), 17 percent less than the 131 million bushels (3.58 million metric tons) disappearance a year earlier.

Old crop rye stocks in all storage positions on June 1, 1981 totaled 4.13 million bushels (105 thousand metric tons), down 66 percent from last year's 12.2 million bushels (310 thousand metric tons). Farm stocks accounted for 2.22 million bushels (56.3 thousand metric tons) and off-farm stocks were 1.91 million bushels (48.4 thousand metric tons). Disappearance from all storage during April and May 1981 totaled 2.70 million bushels (68.7 thousand metric tons) compared with 2.82 million bushels (71.6 thousand metric tons) disappearance for the comparable period last year.

Soybean stocks in all positions June 1, 1981 totaled 684 million bushels (18.6 million metric tons), down 12 percent from a year ago but 30 percent above June 1 two years ago. Farm stocks of 366 million bushels (9.97 million metric tons) were 8 percent less than last June 1 but 52 percent above June 1, 1979. Off-farm stocks totaled 317 million bushels (8.63 million metric tons), down 16 percent from June 1 last year but 11 percent above June 1, 1979.

The September - May utilization is indicated at 1.49 billion bushels (40.6 million metric tons), down 10 percent from the same period a year earlier. During September - May about 601 million bushels (16.4 million metric tons) were exported and about 801 million bushels (21.8 million metric tons) were crushed--down 15 and 8 percent, respectively, from a year earlier.

Old crop flaxseed stocks in all positions on June 1, 1981 totaled 2.88 million bushels (73.3 thousand metric tons), down 43 percent from June 1 stocks a year ago but 12 percent above two years earlier. Farm stocks, at 1.22 million bushels (31.0 thousand metric tons), were 54 percent below a year ago, while off-farm stocks at 1.66 million bushels (42.3 thousand metric tons), were down 29 percent. Indicated disappearance during April-May 1981 was 1.53 million bushels (38.8 thousand metric tons), compared with 2.20 million bushels (55.8 thousand metric tons) for the same period a year earlier.
