CORN, SOYBEAN AND WHEAT STOCKS ABOVE A YEAR EARLIER

Corn stocks on January 1, 1982 totaled a record high 175 million metric tons, up 18 percent from a year ago, according to the Crop Reporting Board. Soybean stocks, at 44.7 million metric tons, were up 8 percent from a year earlier. Stocks of the four feed grains (corn, sorghum, barley and oats) totaled 205 million metric tons, 19 percent above the January 1, 1981 total. Changes from last year, in addition to corn and soybeans, were: sorghum -- up 46 percent, oats -- down 7 percent, and barley -- up 10 percent. All wheat stocks totaled 59.2 million metric tons, 14 percent more than a year earlier.

CORN stored in all positions on January 1, 1982 totaled a record high 6.90 billion bushels (175 million metric tons), 18 percent more than last year's level of 5.86 billion bushels (149 million metric tons). Of the total corn on hand January 1, 1982, 72 percent or 4.97 billion bushels (126 million metric tons) was stored on farms. This is 20 percent more than the January 1 farm stocks a year ago. Off-farm stocks, at 1.93 billion bushels (49.1 million metric tons), were up 13 percent from last year's level.

Disappearance from all storage positions during October-December 1981 totaled 2.33 billion bushels (59.3 million metric tons), down 3 percent from the comparable quarter a year ago.

Of the January 1, 1982 total corn stored in all positions, 943 million bushels or 14 percent were under Government control -- 246 million bushels were owned by the Commodity Credit Corporation and 697 million bushels were held under farmer-owned reserve.

SORGHUM in all storage positions on January 1, 1982 totaled 679 million bushels (17.3 million metric tons), 46 percent more than a year earlier and 5 percent above the same date in 1980. Farm stocks of 254 million bushels (6.45 million metric tons) were 83 percent above a year ago and off-farm holdings, at 426 million bushels (10.8 million metric tons), were up 31 percent from January 1, 1981. Disappearance during October-December 1981 totaled 310 million bushels (7.86 million metric tons), up 18 percent from the comparable period a year earlier but 3 percent below the October - December 1979 disappearance. Of the January 1 total sorghum stocks, 106 million bushels were under government control--67.4 million bushels in the farmer-owned reserve and 38.3 million bushels in Commodity Credit Corporation facilities.

OATS in all storage positions on January 1, 1982 totaled 365 million bushels (5.29 million metric tons), down 7 percent from a year ago, 23 percent below January 1, 1980, and the lowest amount in storage on January 1 since records began in 1942. Farm stocks amounted to 314 million bushels (4.55 million metric tons), 5 percent less than a year earlier. Off-farm holdings totaled 51.1 million bushels (742 thousand metric tons), down 17 percent from January 1, 1981. January 1, 1982 stocks indicate the October - December 1981 disappearance was 93.0 million bushels (1.35 million metric tons), down 1 percent from the comparable period last year, but 2 percent above the October - December 1979 disappearance. Of the January 1 total oat stocks, only 1.71 million bushels were under government control.

BARLEY stored in all positions on January 1, 1982 totaled 332 million bushels (7.24 million metric tons), 10 percent more than a year earlier but 9 percent less than January 1, 1980. Off-farm stocks, at 102 million bushels (2.22 million metric tons), were 14 percent less than a year earlier. Farm stocks, at 231 million bushels (5.02 million metric tons), were 24 percent more than the stocks on hand January 1, 1981. Disappearance during October - December 1981 was 119 million bushels (2.58 million metric tons), up 33 percent from the corresponding period a year earlier. Of the January 1 total barley stocks on hand, 18.6 million bushels were under Government control -- 3.31 million bushels were owned by the Commodity Credit Corporation and 15.3 million bushels were held in the farmer-owned reserve.

ALL WHEAT stored in all positions on January 1, 1982 totaled 2.17 billion bushels (59.2 million metric tons), 14 percent more than last year's 1.90 billion bushels (51.8 million metric tons) and 27 percent more than January 1, 1980. Farm stocks amounted to 955 million bushels (26.0 million metric tons) or 44 percent of the total January 1, 1982 wheat stocks. Farm stocks on January 1, 1981 were 753 million bushels (20.5 million metric tons) or 40 percent of the total stocks. Off-farm wheat stocks at the beginning of 1982 totaled 1.22 billion bushels (33.2 million metric tons), 6 percent more than the January 1, 1981 total of 1.15 billion bushels (31.3 million metric tons). Indicated disappearance during the October-December 1981 quarter totaled 560 million bushels (15.2 million metric tons). Disappearance for the comparable period a year ago was 569 million bushels (15.5 million metric tons). Wheat under government control on January 1 totaled 659 million bushels--472 million in the farmer owned reserve and 187 million in the Commodity Credit Corporation.

DURUM WHEAT stored in all positions on January 1, 1982 totaled 152 million bushels (4.15 million metric tons), 47 percent more than last year's 103 million bushels (2.82 million metric tons) and 42 percent more than January 1, 1980. Farm stocks of 121 million bushels (3.30 million metric tons) are 64 percent more than last year's 74.0 million bushels (2.01 million metric tons). This year's farm stocks of durum wheat account for 80 percent of the total durum wheat stocks compared with 72 percent last year. Off-farm stocks of 30.9 million bushels (842 thousand metric tons), are 5 percent greater than last year's 29.4 million bushels (801 thousand metric tons). Disappearance during the October-December 1981 quarter totaled 36.9 million bushels (1.00 million metric tons) nearly double the 19.4 million bushels (529 thousand metric tons) disappearance during the comparable period a year earlier.

RYE stored in all positions on January 1, 1982 totaled 7.83 million bushels (199 thousand metric tons), 16 percent less than last year's 9.35 million bushels (237 thousand metric tons). Farm stocks of 5.66 million bushels (144 thousand metric tons) accounted for 72 percent of total rye stocks on January 1, 1982. Last year, 5.88 million bushels (149 thousand metric tons) or 63 percent of total rye stocks were on farms. January 1, 1982 off-farm rye stocks totaled 2.17 million bushels (55.2 thousand metric tons) compared with last year's 3.47 million bushels (88.1 thousand metric tons). Total disappearance during the October-December 1981 quarter was 6.62 million bushels (168 thousand metric tons) compared with 9.16 million bushels (233 thousand metric tons) during the corresponding period a year earlier.

SOYBEANS in all storage positions on January 1, 1982 totaled 1.64 billion bushels (44.7 million metric tons), up 8 percent from a year ago. Farm stocks were up 23 percent to 901 million bushels (24.5 million metric tons). However, off-farm stocks, at 743 million bushels (20.2 million metric tons), were down 6 percent from January 1, 1981.

The September-December 1981 indicated disappearance, based on supply and January 1 stocks, was 705 million bushels (19.2 million metric tons), up 12 percent from the 630 million bushels (17.2 million metric tons) during the same period a year ago. Exports totaled about 320 million bushels (8.71 million metric tons) and crushings accounted for about 380 million bushels (10.3 million metric tons) during the September-December period.


FLAXSEED stocks in all positions on January 1, 1982 totaled 5.10 million bushels (129 thousand metric tons), down 22 percent from the January 1 total a year earlier and 47 percent less than two years ago. Farm stocks, at 3.23 million bushels (82.1 thousand metric tons) were up 3 percent from a year ago, while off-farm stocks, at 1.86 million bushels (47.4 thousand metric tons), were down 46 percent from a year ago. Indicated disappearance during October - December 1981 was 1.38 million bushels (35.1 thousand metric tons) compared with 2.03 million bushels (51.5 thousand metric tons) in the same three-month period a year ago.

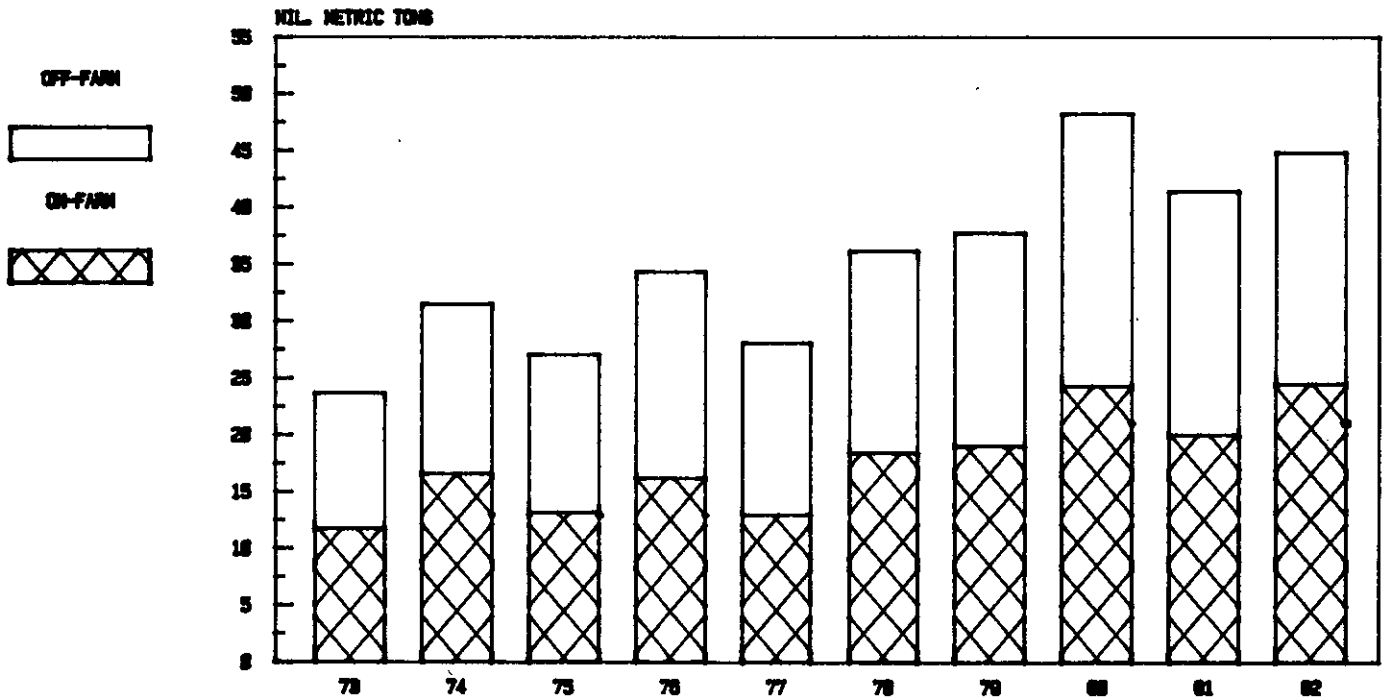

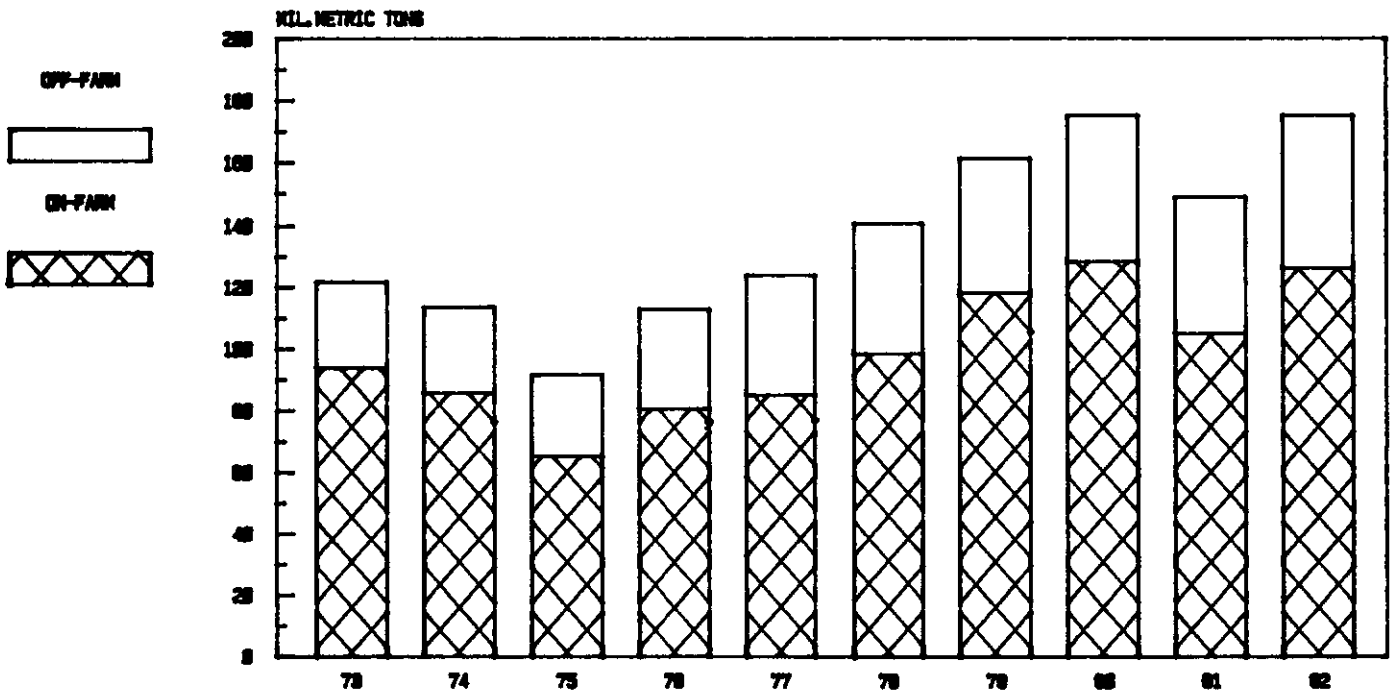

OFF-FARM GRAIN STORAGE CAPACITY

Capacity of off-farm commercial grain storage in the Nation totaled 7.25 billion bushels on January 1, 1982. This is an increase of 1 percent from a year earlier. Expansion of capacity occurred during the year in 30 States and New England while 10 States registered declines and 2 States showed no change.

Kansas retained its number one rank in total storage capacity followed by Illinois, Texas, Iowa, and Nebraska. These top five States together accounted for 51 percent of the Nation's off-farm grain storage capacity.

Several States made large additions to capacity during 1981. These include: Illinois --- up 13 million bushels; Colorado, Indiana, Michigan, Missouri, Nebraska, Ohio, and Wisconsin, each showing increases of 5 to 9 million bushels. The largest decline was in Kansas where storage capacity decreased 6 million bushels.

Capacity data by States include all elevators, warehouses, terminals, merchant mills, other storages, and oilseed crushers which store grain, soybeans, or flaxseed. Capacity data exclude warehouses used to store only rice or peanuts, oilseed crushers processing only cottonseed or peanuts, tobacco warehouses, seed warehouses, and storages that handle only dry edible beans or dry edible peas.

NUMBER OF OFF-FARM GRAIN STORAGE FACILITIES

There were an estimated 14,792 off-farm grain storage facilities in operation on January 1, 1982, a decline of 152 from a year earlier. States with the largest number of facilities this year include: Illinois -- 1129, Iowa -- 1037, Kansas -- 994, Texas -- 941, and Minnesota -- 844 firms.

Data users are advised, that some differences exist between States, in the procedure for making counts of facilities in the grain stocks universe. In a few instances, the count includes only the headquarters which report for more than one facility. This does not affect the data on total capacity. The same facilities are included in the number of facilities and in the capacity data.
