CORN STOCKS - LOWEST SINCE 1976

Stocks of old crop corn in all positions on October 1, 1984 totaled 18.3 million metric tons, 77 percent below the record high October 1 stocks of last year. Stocks of feed grains (corn, sorghum, oats, and barley), at 44.3 million metric tons, were down 59 percent from a year ago. Wheat stocks totaled 74.1 million metric tons, down 8 percent from last year.

OLD CROP CORN in all positions on October 1, 1984 totaled 722 million bushels (18.3 million metric tons), 77 percent below the record high October 1 stocks of last year.

Of the total corn stocks on October 1, 1984, 48 percent, or 347 million bushels (8.81 million metric tons), were stored on the farm and 52 percent, or 375 million bushels (9.53 million metric tons), were stored off the farm. Both the on-farm and off-farm stocks are down 77 percent from October 1 a year ago.

Indicated disappearance during the June-September period was 1.42 billion bushels (36.1 million metric tons) down 21 percent from the comparable period a year ago. The marketing year disappearance (October 1, 1983 through September 30, 1984) was 6.56 billion bushels (167 million metric tons), down 10 percent from the corresponding period a year ago. Usage, by category and percent change, for the marketing year follows: Exports - fractionally higher than last year; food, processing and seed use - up 9 percent from last year; and feed and residual - down about 18 percent from last year. The decline in feed use was partially offset by an increase in wheat feeding.

OLD CROP SORGHUM in all positions on October 1, 1984, totaled 250 million bushels (6.35 million metric tons), down 38 percent from a year earlier and 16 percent lower than October 1, 1982. Farm stocks totaled 37.2 million bushels (945 thousand metric tons), 38 percent less than a year earlier. Off-farm holdings, at 213 million bushels (5.41 million metric tons), were down 37 percent from a year earlier. Indicated disappearance from all storage positions during June through September was 117 million bushels (2.98 million metric tons), down 9 percent from the disappearance during the same period a year earlier.

OATS stored in all positions on October 1, 1984, totaled 474 million bushels (6.88 million metric tons), down 6 percent from October 1, 1983. Farm stocks, at 398 million bushels (5.77 million metric tons), were 7 percent less than on October 1 a year ago, and off-farm holdings, at 76.6 million bushels (1.11 million metric tons), declined 3 percent from a year earlier. Indicated usage during June-September was 179 million bushels (2.60 million metric tons), down 6 percent from the comparable period last year.


BARLEY stored in all positions on October 1, 1984, totaled 583 million bushels (12.7 million metric tons), 13 percent more than on October 1 a year ago and 18 percent greater than on the same date in 1982. Of the total barley stocks on hand October 1, 1984, 70 percent, or 411 million bushels (8.95 million metric tons), was stored on farms. Farm stocks were 20 percent more than a year ago. Off-farm stocks, at 173 million bushels (3.76 million metric tons), were up less than one percent from last October 1 level. Indicated disappearance during June-September 1984 was 211 million bushels (4.60 million metric tons), 1 percent more than the corresponding period a year ago.

ALL WHEAT stored in all positions on October 1, 1984 totaled 2.72 billion bushels (74.1 million metric tons), 8 percent less than the 2.96 billion bushels (80.4 million metric tons) stored on October 1 a year ago. Farm stocks of 1.20 billion bushels (32.7 million metric tons) accounted for 44 percent of the total. Wheat stored off-farms totaled 1.52 billion bushels (41.5 million metric tons). Farm stocks are 3 percent below October 1, 1983, while off-farm stocks are down 11 percent from last year. Indicated disappearance of all wheat during June-September 1984 stands at 1.24 billion bushels (33.9 million metric tons) compared with 980 million bushels (26.7 million metric tons) during the same period a year ago. Disappearance during the June-September period implies a higher feed usage than normal.

DURUM WHEAT stocks in all positions October 1, 1984 totaled 179 million bushels (4.87 million metric tons), up 12 percent from the 159 million bushels (4.33 million metric tons) on hand October 1, 1983. Farm stocks, at 127 million bushels (3.47 million metric tons), are 13 percent more than the 113 million bushels (3.07 million metric tons) on hand a year earlier. Off-farm stocks, at 51.4 million bushels (1.40 million metric tons), are 11 percent above October 1 last year. Indicated June-September 1984 disappearance of durum wheat is 27.5 million bushels (748 thousand metric tons), down 45 percent from the 49.7 million bushels (1.35 million metric tons) recorded for the comparable period a year earlier.

OLD CROP SUNFLOWER: The October 1, 1984 carryover of old crop sunflower into the 1984-85 marketing year totaled 71.0 million pounds (32.2 thousand metric tons).
