CORN stored in all positions on June 1, 1987 is estimated at 6.33 billion bushels (161 million metric tons), 27 percent more than the June 1, 1986 level of 4.99 billion bushels (127 million metric tons). Of the total corn stocks on hand June 1, 1987, 55 percent or 3.49 billion bushels (88.7 million metric tons) were stored on farms. Farm stocks are 11 percent higher than June 1, 1986. Off-farm stocks, at 2.84 billion bushels (72.1 million metric tons), are up 54 percent from last June 1.

Indicated disappearance from all storage positions during March-May 1987 totaled 1.92 billion bushels (48.7 million metric tons).

OLD CROP WHEAT stored in all positions on June 1, 1987 is estimated at 1.81 billion bushels (49.4 million metric tons). This is down 5 percent from the June 1, 1986 level. Off-farm stocks, at 1.25 billion bushels (34.2 million metric tons), comprise 69 percent of the total stocks. The off-farm level is up 3 percent from a year ago. Wheat stored on-farms totals 560 million bushels (15.2 million metric tons), off 18 percent from June 1 last year.

The indicated March-May 1987 disappearance from all positions is 435 million bushels (11.8 million metric tons).

OLD CROP DURUM WHEAT stocks in all positions on June 1, 1987 totaled 94.6 million bushels (2.58 million metric tons), down 22 percent from June 1, 1986. Farm stocks are placed at 49.3 million bushels (1.34 million metric tons), 38 percent less than last June 1. The indicated March-May 1987 disappearance from all storage positions is 34.6 million bushels (941 thousand metric tons).

SOYBEANS stored in all positions on June 1, 1987 totaled 865 million bushels (23.5 million metric tons), up 2 percent from June 1, 1986 and 42 percent above June 1, 1985. Farm stocks are estimated at 310 million bushels (8.44 million metric tons), 25 percent less than on June 1, 1986. Off-farm stocks, at 555 million bushels (15.1 million metric tons), are up 27 percent from June 1 a year ago.


Indicated disappearance from all storage positions during March-May 1987 totaled 520 million bushels (14.2 million metric tons). Indicated disappearance for the marketing year totaled 1.68 billion bushels (45.7 million metric tons).

OLD CROP BARLEY in all storage positions on June 1, 1987 were a record high 336 million bushels (7.31 million metric tons), 3 percent more than the June 1, 1986 stocks of 325 million bushels (7.07 million metric tons). Farm stocks were 194 million bushels (4.22 million metric tons) and accounted for 58 percent of the June 1, 1987 total stocks. Farm stocks were 3 percent less than June 1 last year. Off-farm stocks, at 142 million bushels (3.08 million metric tons), are 13 percent more than a year earlier. Indicated disappearance during this crop marketing year (June 1, 1986 - May 31, 1987) was 600 million bushels (13.1 million metric tons).

OLD CROP OAT stocks in all storage positions on June 1, 1987 totaled 133 million bushels (1.93 million metric tons), down 28 percent from June 1, 1986. Farm stocks, at 103 million bushels (1.50 million metric tons), are down 30 percent from June 1, 1986. Off-farm stocks, at 29.4 million bushels (427 thousand metric tons), are 19 percent less than on June 1 last year. Indicated disappearance during the marketing year (June 1, 1986 - May 31, 1987) is 436 million bushels (6.32 million metric tons).

SORGHUM stored in all positions on June 1, 1987 is estimated at 822 million bushels (20.9 million metric tons), up 30 percent from the stocks on hand June 1, 1986. Off-farm stocks, at 673 million bushels (17.1 million metric tons), are 82 percent of the total stocks and are up 37 percent from last June 1. On-farm stocks total 149 million bushels (3.79 million metric tons), 8 percent above a year ago. The indicated disappearance from all positions September 1986-May 1987 is 671 million bushels (17.0 million metric tons).
