OLD CROP CORN stored in all positions on September 1, 1987 is estimated at 4.88 billion bushels (124 million metric tons). Of the total stocks, 2.28 billion bushels (58.0 million metric tons) were stored on the farm and 2.60 billion bushels (66.0 million metric tons) were stored off the farm.

Indicated disappearance from all storage positions during June-August 1987 totaled 1.45 billion bushels (36.8 million metric tons), up 53 percent from the comparable period last year.

OLD CROP SORGHUM stored in all positions on September 1, 1987 total 732 million bushels (18.6 million metric tons), up 33 percent from September 1 a year ago. Off-farm stocks, at 628 million bushels (16.0 million metric tons), comprise 86 percent of the total. The off-farm level is 37 percent more than last September 1. On-farm stocks, at 103 million bushels (2.62 million metric tons), are up 13 percent from last year. The indicated disappearance from all positions during June-August 1987 is 92.2 million bushels (2.34 million metric tons), up 17 percent from the same quarter last year.


OLD CROP SOYBEANS: The September 1, 1987 carryover of old crop soybeans is 436 million bushels (11.9 million metric tons), 19 percent below September 1 last year but 38 percent above the September 1, 1985 stocks level. Soybeans stored on-farm totaled 108 million bushels (2.94 million metric tons), down 35 percent from September 1, 1986, and account for 25 percent of the soybean stocks stored in all positions on September 1, 1987. Off-farm stocks, at 328 million bushels (8.94 million metric tons), were 11 percent less than a year ago.

Indicated disappearance during June-August 1987 totaled 428 million bushels (11.7 million metric tons), 37 percent more than the corresponding quarter last year.

WHEAT stocks in all positions on September 1, 1987 total 2.96 billion bushels (80.5 million metric tons), 6 percent less than stocks on hand September 1, 1986. Off-farm stocks are placed at 1.81 billion bushels (49.3 million metric tons), or 61 percent of all stocks. The off-farm level is 3 percent less than a year earlier. Wheat stored on farms is 1.15 billion bushels (31.2 million metric tons), down 11 percent from September 1 last year.

DURUM WHEAT stored in all positions on September 1, 1987 is placed at 147 million bushels (3.99 million metric tons), down 17 percent from storages on September 1, 1986. Farm stocks total 94.1 million bushels (2.56 million metric tons), down 25 percent from last September 1. The indicated June-August 1987 disappearance from all positions is 38.5 million bushels (1.05 million metric tons), off one percent from the same period a year ago.
