CORN stored in all positions on December 1, 1987 is estimated at 9.77 billion bushels (248 million metric tons). Of the total stocks, 6.10 billion bushels (155 million metric tons) were stored on the farm and 3.67 billion bushels (93.1 million metric tons) were stored off the farm. The September-November 1987 indicated disappearance based on supply and December 1 stocks is 2.18 billion bushels (55.3 million metric tons), 10 percent above the disappearance of 1.98 billion bushels (50.4 million metric tons) during September-November 1986.


ALL WHEAT stored in all positions on December 1, 1987 is placed at 2.51 billion bushels (68.2 million metric tons), down 6 percent from December 1, 1986. Off-farm stocks total 1.53 billion bushels (41.8 million metric tons), 61 percent of all stocks. The off-farm storage is 5 percent less than December 1 last year. Farm stocks are 971 million bushels (26.4 million metric tons), down 9 percent from December 1, 1986. The indicated disappearance from all positions during September-November 1987 is 483 million bushels (13.1 million metric tons), virtually unchanged from the disappearance during the same quarter a year ago.

DURUM WHEAT stocks in all positions on December 1, 1987 is estimated at 120 million bushels (3.27 million metric tons), down 22 percent from durum in storage on December 1, 1986. Farm stocks, at 76.9 million bushels (2.09 million metric tons), are 64 percent of all durum stocks. Stocks on farms are 21 percent less than December 1 a year ago. The indicated September-November 1987 disappearance from all positions is 26.3 million bushels (716 thousand metric tons), up 13 percent from the disappearance during the same quarter in 1986.

SOYBEANS stored in all positions on December 1, 1987 totaled 1.75 billion bushels (47.8 million metric tons), 10 percent less than on December 1, 1986. Farm stocks totaled 865 million bushels (23.5 million metric tons), down 18 percent from last December 1. Off-farm stocks, at 889 million bushels (24.2 million metric tons), were 1 percent less than December 1, 1986. The September-November 1987 indicated disappearance, based on supply and December 1 stocks, is 587 million bushels (16.0 million metric tons), up 13 percent from the 520 million bushels (14.1 million metric tons) disappearance during the same period a year ago.

ON-FARM GRAIN STORAGE CAPACITY

The National Agricultural Statistics Service collects on-farm grain storage capacity data as part of the Agency's quarterly agricultural surveys. The capacity data from the December Agricultural Survey is published annually for the United States. State indications will not be released each year. The latest State indications were published in GRAIN STOCKS, released January 15, 1987. The data published are indications computed directly from the survey and as such are subject to sampling fluctuations. The data do provide indications of farm storage capacity within a range indicated by the sampling error. A measure of this sampling error is expressed as a percent of the survey indications (coefficient of variation). When comparing the data year to year, this survey variability must be taken into account.

The December 1, 1987, on-farm storage capacity sample survey indication for the United States is 13.6 billion bushels with a sampling error of 1.2 percent. This means that chances are 2 out of 3 that if the storage capacity indications from all possible samples were averaged together the result would be within plus or minus 1.2 percent of 13.6 billion bushels. Chances are 9 out of 10 (90 percent confidence level) that the difference will not exceed 1.9 percent or a range of 13.4 to 13.9 billion bushels. The December 1, 1986, on-farm storage capacity indication was 13.8 billion bushels with a sampling error of 1.0 percent or a range of 13.6 to 14.1 million bushels at the 90 percent confidence level. Statistically, there is no difference between the December 1, 1986 and December 1, 1987 indications.

OFF-FARM GRAIN STORAGE CAPACITY

Capacity of off-farm commercial grain storage totaled 9.61 billion bushels in the United States on December 1, 1987. Capacity increased 5 percent from the December 1, 1986 revised figure of 9.12 billion bushels. The largest increase in capacity occurred in Illinois - 76 million bushels; followed by: Minnesota - 73 million bushels, Iowa - 69 million bushels, and Nebraska - 66 million bushels. Off-farm storage capacity increased in 29 States and the New England States, while decreasing in 13 States.

Illinois continues to lead all States in off-farm storage capacity, followed by: Iowa, Kansas, Texas, and Nebraska. The top 5 States account for 53 percent of the Nation's off-farm storage capacity on December 1, 1987.

State capacity data include all elevators, warehouses, terminals, merchant mills, other storages, and oilseed crushers which store grain, soybeans, sunflower, or flaxseed. Capacity data exclude warehouses used to store only rice or peanuts, oilseed crushers processing only cotton seed or peanuts, tobacco warehouses, seed warehouses, and storages that handle only dry edible beans.

NUMBER OF OFF-FARM GRAIN STORAGE FACILITIES

Off-farm grain storage facilities totaled 13,873 on December 1, 1987, 173 fewer than on December 1, 1986. States with the largest number of facilities are: Illinois - 1290, Kansas - 937, Iowa - 917, Texas - 861, and Minnesota - 818.

Data users are advised that some differences may exist, between States, in the procedure for making counts of facilities in the grain storage universe. In a few instances, the count includes only the headquarters which report for more than one facility. This does not affect the data on total capacity.
