Corn Stocks Up 92 Percent

Old crop corn stored in all positions on September 1, 1993, is estimated at 2.11 billion bushels, up 92 percent from September 1, 1992. Of the total stocks, 1.07 billion bushels are stored on farms, up 77 percent from last year. Off-farm stocks, at 1.04 billion bushels, are up 111 percent from a year earlier. The indicated disappearance from all positions for the June-August quarter is 1.60 billion bushels, 3 percent below the disappearance for the same quarter a year earlier.

Old crop sorghum in all storages on September 1, 1993, is estimated at 175 million bushels, up 229 percent from September 1, 1992. Of the total, 140 million bushels are off-farms. The fourth quarter disappearance from all positions is 89.8 million bushels, up 57 percent from the same period in 1992.

Old crop soybeans stored in all positions on September 1, 1993, totaled 292 million bushels, 5 percent above holdings a year ago. On-farm stocks, at 125 million bushels, are up 19 percent from September 1, 1992. Off-farm stocks at 167 million, are down 4 percent from last year.

Indicated disappearance for the September 1992 - August 1993 marketing year totaled 2.18 billion bushels, 7 percent above disappearance during the comparable period a year earlier.

Barley stored in all positions on September 1, 1993, is estimated at 409 million bushels, 2 percent below the stocks of September 1, 1992. Of the total barley stocks on hand, 285 million bushels are stored on farms, 9 percent above a year earlier. Off-farm stocks, at 124 million bushels, are 21 percent below last year.


All wheat stored in all positions on September 1, 1993, is placed at 2.16 billion bushels, up 2 percent from last September 1. Farm stocks are 1.00 billion bushels and off-farm stocks total 1.15 billion. Both are up 2 percent from a year ago.

Durum wheat stocks in all positions total 110 million bushels, down 1 percent from last September. Farm stocks, at 89.0 million bushels, are off 2 percent from a year ago. Stocks in off-farm storage total 21.1 million bushels, up 1 percent.

Oats stored in all positions on September 1, 1993, are 221 million bushels, 25 percent below a year earlier. Of the total oat stocks on hand, 163 million bushels are stored on farms, 18 percent below last year. Off-farm stocks totaled 57.9 million bushels, 39 percent below last year.

Reliability of September 1, 1993, Grain Stocks Estimates

Survey Procedures: The grain stocks estimates in this report are based on surveys conducted during the first 2 weeks of September. Separate surveys were conducted to obtain the on-farm and off-farm estimates. The on-farm stocks survey is a probability survey that included about 70,000 operators selected from a list of producers that ensures that all operations in the U.S. have a chance to be selected. These producers were asked to provide the total quantities of grain on their operations as of September 1, 1993. This included all whole grains and oilseeds stored whether for feed, seed, or sale as well as any stored under a Government program.

The 1993 small grain crops, unlike most years, is running unusually late. Harvest progress is considerably behind normal and a significant portion of the barley, oats, durum wheat, and other wheat remained unharvested as of the grain stocks reference date September 1, 1993. After the beginning of the marketing year, unharvested grain is counted in the production and stocks estimates. On-farm questionnaires are designed to determine if producers included their unharvested small grain in their stocks report. If unharvested grain was not included, the producer is then asked again stocks questions and requested to include unharvested grain.

The off-farm stocks survey is an enumeration of all known commercial grain storage facilities. This includes approximately 13,000 facilities with about 9 billion bushels of storage capacity. An effort is made to obtain a report from all facilities. Reports of stock holdings are normally received from operations covering about 90 percent of the capacity. Estimates are made for missing facilities to make the survey complete.

Estimation Procedures: On-farm and off-farm survey data are reviewed at the State and national levels for reasonableness, consistency with historical estimates, and current crop size. After estimates are made for on-farm and off-farm, the total of these two are combined and evaluated using the balance sheet approach. This method utilizes other sources of data to check the reasonableness of the stocks estimates. Estimates of production, imports, exports, crushings, milling, and all other recorded uses of grain and oilseeds are reviewed to make sure beginning stocks, production, utilization, and ending stocks are within reasonable balance and present the best possible estimate of stocks.

Revision Policy: On-farm and off-farm stocks are subject to revision the quarter following initial publication and again in the following December 1 "Grain Stocks" report published in January each year. Revisions can be made when late reports are received, errors are detected in reporting and calculating, and production estimates are revised. Estimates will also be reviewed after data for the 5-year Census of Agriculture, conducted by the Department of Commerce, are available. No revisions will be made after that date. In the past 5 years, revisions of corn, soybeans, and all wheat September 1 stocks have been less than 1 percent at the U.S. level except in one instance.

Reliability: Reliability of the on-farm and off-farm stocks must be treated separately because the survey design for the two surveys are drastically different. The on-farm stocks estimates are subject to sampling variability because all operations holding on-farm stocks are not included in the sample. This variability, as measured by the relative standard error at the U.S. level, is approximately 1.9 percent for corn, 3.9 percent for soybeans, and 1.7 percent for all wheat. This means that chances are approximately 95 out of 100 that survey estimates for stocks will be within plus or minus 3.8 percent for corn, 7.8 percent for soybeans, and 3.4 percent for all wheat of the value that could be developed by averaging the estimates produced from all possible samples selected from the same population and surveyed using the same procedures. The relative standard error for sorghum, barley, and oats are 7.7, 3.2, and 3.0, respectively. Sampling errors cannot be applied directly to the on-farm stocks published in this report to determine confidence intervals since the Agricultural Statistics Board estimates represent a composite of information from more than a single source.

Surveys estimates are also subject to non-sampling errors such as omission, duplication, imputation for missing data, and mistakes in reporting, recording, and processing the data. Off-farms, as well as on-farms stocks, are subject to these types or errors. These errors cannot be measured directly, but they are minimized through rigid quality controls in the data collection process and a careful review of all reported data for consistency and reasonableness.

At the beginning of the survey period for the September 1, 1993, "**Grain Stocks**" report, small grain harvest was running considerably later than usual. Six percent of the winter wheat was still unharvested when the average is only one percent. Approximately 70 percent of the spring wheat remained to be harvested compared to an average of 18 percent. Oats and barley also lagged normal harvesting progress.

The September 1 "**Grain Stocks**" report indicates inventory at the end of the first quarter of the 1993 marketing year for small grains and by definition **includes** the unharvested portion of the crop. Corn, sorghum, and soybean stocks are the ending inventories for the 1992 and earlier crops and **exclude** all of the 1993 crop.

The final small grain acreage, yield, and production estimates are published in the October "**Crop Production**" report. This year producers reporting unharvested grain on the survey will be resurveyed and States will have the opportunity to update production estimates in the **Annual Summary**, published January 12, 1994.

The next "**Grain Stocks**" report will be released in January 1994.
