LIVESTOCK SLAUGHTER, MEAT AND LARD PRODUCTION, 1969

Production of red meat in 48 States during 1969 totaled about the same as in 1968, according to the Crop Reporting Board. The 1969 total of 35,295 million pounds of red meat includes estimated slaughter on farms in addition to commercial slaughter in plants. Beef production totaled 21,126 million pounds, up 1 percent from 1968. Veal production dropped 8 percent to 673 million pounds. Pork production was 12,946 million pounds, down 1 percent. Production of lamb and mutton dropped 9 percent to 550 million pounds. Beef accounted for 60 percent of total red meat production in 1969, pork 36 percent, veal 2 percent, and lamb and mutton 2 percent. Lard production totaled 1,904 million pounds, down 8 percent from 1968. Commercial production of chicken and turkey meat totaled 9,492 million pounds in 1969, up 6 percent from 1968.

The total number of cattle slaughtered in 1969 was 36 million head, of which 86 percent were slaughtered in Federally inspected plants, 13 percent in other plants and 1 percent on farms. The 1969 calf slaughter of 5 million head consisted of 73 percent slaughtered in Federally inspected plants, 24 percent in other plants and 3 percent on farms. Of the 1969 hog slaughter of 85 million head, Federally inspected plants handled 89 percent, other plants 10 percent and 1 percent were slaughtered on farms. Sheep and lamb slaughter totaled 11 million head in 1969, with 92 percent slaughtered in Federally inspected plants, 6 percent in other plants and 2 percent on farms.

The average live weight of all cattle slaughtered during 1969 was 1,015 pounds, up 3 pounds from 1968, while calves averaged 241 pounds, up 6 pounds. Average live weight of hogs slaughtered held unchanged from 1968 at 239 pounds. Sheep and lambs averaged 103 pounds, up 1 pound from 1968.

Monthly commercial slaughter by States in Tables 7 through 18 includes slaughter in Federally inspected and other slaughter plants, comparable with preliminary data published in monthly reports. Farm slaughter estimates are available only on a quarterly basis, as shown in Tables 3 through 6.

The rank of States by number of head slaughtered in plants is shown for each species in Table 19.

The number of livestock slaughtering establishments -- Federally inspected and other -- on March 1, 1968, 1969, and 1970 are shown by States in Table 20. A more detailed report, entitled Number of Livestock Slaughter Plants, 1970, will be issued May 13, 1970.
