LIVESTOCK SLAUGHTER, MEAT, AND LARD PRODUCTION, 1971

Production of red meat in the 48 States during 1971 was 4 percent more than in 1970, according to the Crop Reporting Board. The 1971 total of 37,756 million pounds of beef, veal, pork, lamb, and mutton includes estimated slaughter on farms in addition to slaughter in commercial plants. Beef production increased 1 percent to 21,870 million pounds in 1971. Veal production continued to decline, dropping 7 percent in 1971 to 546 million pounds. Pork production increased 10 percent to 14,786 million pounds in 1971. Production of lamb and mutton totaled 554 million pounds, up slightly from 1970. In 1971, beef accounted for 58 percent of the red meat total, pork 39 percent, lamb and mutton 2 percent, and veal about 1 percent. Lard production, at 1,960 million pounds, was up 2 percent from last year. Commercial production of chicken and turkey meat totaled 10,357 million pounds in 1971, up 1 percent from 1970.

Cattle slaughter totaled 35,897 million head in 1971, of which 87 percent were slaughtered in Federally inspected plants, 12 percent in other plants, and 1 percent on farms. Calf slaughter totaled 3,821 million head, with 73 percent in Federally inspected plants, 23 percent in other plants, and 4 percent on farms. The 1971 hog slaughter of 95,550 million head consisted of 91 percent slaughtered under Federal inspection, 8 percent in other plants, and 1 percent farm slaughter. Of the 10,967 million head of sheep and lambs slaughtered in 1971, 94 percent were in Federally inspected plants, 4 percent in other plants, and 2 percent on farms.

The average live weight of all cattle slaughtered in 1971 was 1,028 pounds, down 7 pounds from 1970. For calves slaughtered in 1971, the average live weight was 254 pounds, an increase of 5 pounds from the previous year. The average live weight of hogs slaughtered was 239 pounds for 1971, 1 pound lighter than in 1970. Sheep and lambs averaged 103 pounds, also 1 pound below 1970.

Quarterly 48 State totals are shown in tables 3-6 for slaughter in Federally inspected plants, other plants, and for farm slaughter. Monthly commercial slaughter by States in tables 7-18 does not include farm slaughter.

The rank of States by number of head slaughtered in 1971 (excluding farm slaughter) is shown for each specie in table 19.

The number of livestock slaughtering plants--Federally inspected and other--on March 1, 1970, 1971, and 1972 is shown by States in table 20.
