PEANUT STOCKS AND PROCESSING JANUARY 31, 1984

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports of their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, because of the number of processors of raw peanuts, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

JANUARY PEANUT STOCKS DOWN 9 PERCENT

Peanut stocks in commercial storage on January 31, 1984, totaled 2.30 billion pounds of equivalent farmer stock, 9 percent less than the amount on hand a year earlier. This total includes 1.51 billion pounds of actual farmer stock compared with 1.61 billion pounds on hand a year ago.

Shelled peanuts on hand totaled 749 million pounds of equivalent farmer stock, compared with 835 million pounds on hand a year ago. Roasting stock totaled 48.7 million pounds, down 45 percent from the 88.9 million pounds on hand a year ago. There were 71.4 million pounds of Commodity Credit Corporation uncommitted stock on hand as of January 31, 1984.

Shelled peanut stocks on January 31, 1984, totaled 563 million pounds of which 513 million pounds were edible grades and 49.6 million pounds were oil stock. Edible grade stocks by type were Virginias, 114 million pounds; Runners, 334 million pounds; and Spanish, 65.2 million pounds.

MILLINGS UP

August 1983-January 1984 millings totaled 1.66 billion pounds, up 2 percent from the same period a year ago. Millings by type were 320 million pounds of Virginias, 1.20 billion pounds of Runners, and 146 million pounds of Spanish.

EDIBLE USES AND CRUSHINGS

Commercial processors utilized 666 million pounds of shelled edible grade peanuts during August-January, compared with 662 million pounds a year earlier. Utilization for peanut butter, at 343 million pounds, was up 4 percent; utilization for peanut candy, at 148 million pounds, was down 2 percent; and utilization for salted peanuts, at 156 million pounds, was down 3 percent.

Crushings for oil, cake, and meal totaled 144 million pounds during the period, up 52 percent from the 94.4 million pounds crushed a year ago.

Deliveries under the Government's Domestic Feeding and Child Nutrition Programs amounted to 9,476,106 pounds of peanut butter, 2,890,416 pounds of roasted peanuts and 753,018 pounds of peanut granules during the first six months of the marketing year.
