PEANUT STOCKS AND PROCESSING APRIL 30, 1985

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports of their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, because of the number of processors of raw peanuts, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

APRIL PEANUT STOCKS

Peanut stocks in commercial storage on April 30, 1985, totaled 2.23 billion pounds of equivalent farmer stock. This total includes 900 million pounds of actual farmer stock.

Shelled peanuts on hand totaled 1.24 billion pounds of equivalent farmer stock. Roasting stock totaled 84.3 million pounds. There were no Commodity Credit Corporation uncommitted stock on hand as of April 30, 1985.

Shelled peanut stocks on April 30, 1985, totaled 936 million pounds of which 922 million pounds were edible grades and 14.4 million pounds were oil stocks. Edible grade stocks by type are Virginias, 194 million pounds; Runners, 656 million pounds; and Spanish, 71.9 million pounds.

MILLINGS

April millings totaled 398 million pounds. Millings by type were 54.3 million pounds of Virginias, 328 million pounds of Runners, and 15.3 million pounds of Spanish.

EDIBLE USE AND CRUSHINGS

Commercial processors utilized 112 million pounds of shelled edible grade peanuts during April. Utilization for peanut butter was 56.3 million pounds, utilization for peanut candy was 24.9 million pounds, and utilization for salted peanuts was 26.4 million pounds.

Crushings for oil, cake, and meal totaled 61.8 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Program amounted to 1,502,110 pounds of peanut butter, 615,648 pounds of roasted peanuts and 138,600 pounds of peanut granules during the month of April.
