## PEANUT STOCKS AND PROCESSING MAY 31, 1986

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports for their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, because of the number of processors of raw peanuts, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

### PEANUT STOCKS

Peanut stocks in commercial storage on May 31, 1986, totaled 1.62 billion pounds of equivalent farmer stock. This total includes 578 million pounds of actual farmer stock.

Shelled peanuts on hand totaled 969 million pounds of equivalent farmer stock. Roasting stock totaled 68.0 million pounds. There were 983 thousand pounds of Commodity Credit Corporation uncommitted stock on hand as of May 31, 1986.

Shelled peanut stocks on May 31, 1986, totaled 729 million pounds, of which 715 million pounds were edible grades and 13.9 million pounds were oil stocks. Edible grade stocks by type were: Virginias, 172 million pounds; Runners, 457 million pounds; and Spanish, 85.7 million pounds.

### MILLINGS

May millings totaled 340 million pounds. Millings by type were: 93.6 million pounds of Virginias, 233 million pounds of Runners, and 13.4 million pounds of Spanish.

### EDIBLE USE AND CRUSHINGS

Commercial processors utilized 109 million pounds of shelled edible grade peanuts during May. Utilization for peanut butter was 52.2 million pounds, utilization for peanut candy was 25.6 million pounds, and utilization for salted peanuts was 26.7 million pounds.

Crushings for oil, cake, and meal totaled 70.5 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 1,218,949 pounds of peanut butter, 568,800 pounds of roasted peanuts and 92,400 pounds of peanut granules during the month of May.
