PEANUT STOCKS AND PROCESSING JUNE 30, 1987

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports for their operations. These reports are based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, because of the number of processors of raw peanuts, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

PEANUT STOCKS

Peanut stocks in commercial storage on June 30, 1987, totaled 1.21 billion pounds of equivalent farmer stock. This total includes 101 million pounds of actual farmer stock.

Shelled peanuts on hand totaled 1.06 billion pounds of equivalent farmer stock. Roasting stock totaled 49.4 million pounds. There was no Commodity Credit Corporation uncommitted stock on hand as of June 30.

Shelled peanut stocks on June 30, 1987, totaled 793 million pounds of which 770 million pounds were edible grades and 23.0 million pounds were oil stocks. Edible grade stocks by type are: Virginias, 133 million pounds; Runners, 575 million pounds; and Spanish, 62.7 million pounds.

MILLINGS

June millings totaled 212 million pounds. Millings by type were: 38.7 million pounds of Virginias; 163 million pounds of Runners; and 10.9 million pounds of Spanish.

EDIBLE USE AND CRUSHINGS

Commercial processors utilized 121 million pounds of shelled edible grade peanuts during June. Utilization for peanut butter was 57.7 million pounds, utilization for peanut candy was 24.8 million pounds, and utilization for salted peanuts was 31.1 million pounds.

Crushings for oil, cake, and meal totaled 43.8 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Program amounted to 3,219,970 pounds of peanut butter and 734,400 pounds of roasted peanuts and 254,130 pounds of peanut granules during the month of June.
