Peanut Stocks Up 56 Percent From Last Year

Peanut stocks in commercial storage totaled 1.33 billion pounds of equivalent farmer stock, compared to 851 million pounds last year. This total includes 181 million pounds of actual farmer stock.

Shelled peanuts on hand totaled 1.06 billion pounds of equivalent farmer stock. Roasting stock totaled 88.8 million pounds. There were 445,000 pounds of Commodity Credit Corporation uncommitted stocks on hand as of June 30, 1992.

Shelled peanut stocks totaled 797 million pounds of which 727 million pounds were edible grades and 70.3 million pounds were oil stocks. Edible grade stocks by type were: Virginias, 130 million pounds; Runners, 552 million pounds; and Spanish, 44.7 million pounds.

June Millings totaled 357 million pounds. Millings by type were 26.9 million pounds of Virginias, 324 million pounds of Runners, and 6.32 million pounds of Spanish.

Commercial processors utilized 134 million pounds of shelled edible grade peanuts during June. Utilization for all peanut butter products was 68.2 million pounds, utilization for peanut candy was 31.4 million pounds, and utilization for snack peanuts was 31.1 million pounds. Crushing for oil, cake, and meal totaled 97.0 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 6,223,803 pounds of peanut butter and 377,712 pounds of roasted peanuts during the month of June. There were no deliveries of peanut granules.

Stocks of treated seed on hand June 30 totaled 1.12 million pounds, compared with 6.78 million pounds on May 31, 1992. Of the June total, 63,000 pounds were Virginias and Valencias, 734,000 pounds were Runners, and 324,000 pounds were Spanish. May stocks of treated seed included 1.58 million pounds of Virginias and Valencias, 4.36 million pounds of Runners, and 844,000 pounds of Spanish.

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports for their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

- 1/ Excludes stocks on farms. Includes stocks owned by or held for account of CCC in commercial storages. Farmer stock on net weight basis.
- 2/ Includes shelled edible grades, shelled oil stock, and shelled seed (untreated).
- 3/ Actual farmer stock, plus roasting stock, plus shelled peanuts X 1.33.
- 4/ Includes straight run oil stock peanuts.
- 5/ Cleaned and unshelled.
- 6/ Excludes peanuts milled for seed.
- 7/ Relates to oil mills only.
- 8/ All crushings regardless of grade.
