Peanut Stocks Down 21 Percent From Last Year

Peanut stocks in commercial storage totaled 1.27 billion pounds of equivalent farmer stock, compared to 1.60 billion pounds last year. This total includes 142 million pounds of actual farmer stock.

Shelled peanuts on hand totaled 1.08 billion pounds of equivalent farmer stock. Roasting stock totaled 51.8 million pounds. There were no Commodity Credit Corporation uncommitted stocks on hand as of June 30, 1994.

Shelled peanut stocks totaled 809 million pounds of which 755 million pounds were edible grades and 54.0 million pounds were oil stocks. Edible grade stocks by type were: Virginias, 104 million pounds; Runners, 610 million pounds; and Spanish, 40.7 million pounds.

June **millings** totaled 189 million pounds. Millings by type were 14.0 million pounds of Virginias, 173 million pounds of Runners, and 1.80 million pounds of Spanish.

Commercial processors utilized 120 million pounds of **shelled edible** grade peanuts during June. Utilization for all peanut butter products was 57.0 million pounds, utilization for peanut candy was 34.4 million pounds, and utilization for snack peanuts was 25.5 million pounds. **Crushing** for oil, cake, and meal totaled 48.2 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 3,464,928 pounds of peanut butter and 177,534 pounds of roasted peanuts during June. There were no deliveries of peanut granules.

Stocks of treated seed on hand June 30 totaled 1.12 million pounds, compared with 10.3 million pounds on May 31, 1994. Of the June total, 132,000 pounds were Virginias and Valencias, 599,000 pounds were Runners, and 386,000 pounds were Spanish. May stocks of treated seed included 2.74 million pounds of Virginias and Valencias, 5.69 million pounds of Runners, and 1.86 million pounds of Spanish.

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports for their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

- 1/ Excludes stocks on farms. Includes stocks owned by or held for account of CCC in commercial storages. Farmer stock on net weight basis.
- 2/ Includes shelled edible grades, shelled oil stock, and shelled seed (untreated).
- 3/ Actual farmer stock, plus roasting stock, plus shelled peanuts X 1.33.
- 4/ Includes straight run oil stock peanuts.
- 5/ Cleaned and unshelled.
- 6/ Excludes peanuts milled for seed.
- 7/ Relates to oil mills only.
- 8/ All crushings regardless of grade.
