Peanut Stocks Up 4 Percent From Last Year

Peanut stocks in commercial storage totaled 2.57 billion pounds of equivalent farmer stock, compared to 2.49 billion pounds last year. This total includes 1.54 billion pounds of actual farmer stock.

Shelled peanuts on hand totaled 950 million pounds of equivalent farmer stock. Roasting stock totaled 84.5 million pounds. There were 298 million pounds of Commodity Credit Corporation uncommitted stocks on hand as of February 28, 1995.

Shelled peanut stocks totaled 714 million pounds of which 697 million pounds were edible grades and 16.5 million pounds were oil stocks. Edible grade stocks by type were: Virginias, 177 million pounds; Runners, 475 million pounds; and Spanish, 45.3 million pounds.

February **millings** totaled 351 million pounds. Millings by type were 86.0 million pounds of Virginias, 242 million pounds of Runners, and 22.7 million pounds of Spanish.

Commercial processors utilized 98.7 million pounds of **shelled edible** grade peanuts during February. Utilization for all peanut butter products was 55.8 million pounds, utilization for peanut candy was 26.6 million pounds, and utilization for snack peanuts was 14.2 million pounds. **Crushing** for oil, cake, and meal totaled 67.6 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 2,652,592 pounds of peanut butter and 178,614 pounds of roasted peanuts during February. There were no deliveries of peanut granules during the month.

Stocks of treated seed on hand February 28 totaled 3.26 million pounds, compared with 1.18 million pounds on January 31, 1995. Of the February total, 2.08 million pounds were Virginias and Valencias, 1.18 million pounds were Runners, and 5,000 pounds were Spanish. January stocks of treated seed included 1.12 million pounds of Virginias and Valencias, 60,000 pounds of Runners, and 5,000 pounds of Spanish.

These Statistics are collected and presented according to the Peanut Statistics Act which requires shellers, crushers and processors of raw peanuts to submit periodic reports for their operations. These reports are usually based on a complete enumeration of all shellers and crushers and all of the larger processors of raw peanuts. However, reports are occasionally received too late to be included in the first tabulation. Allowances are made for these missing reports and revised totals are published in the next report.

- 1/ Excludes stocks on farms. Includes stocks owned by or held for account of CCC in commercial storages. Farmer stock on net weight basis.
- 2/ Includes shelled edible grades, shelled oil stock, and shelled seed (untreated).
- 3/ Actual farmer stock, plus roasting stock, plus shelled peanuts X 1.33.
- 4/ Includes straight run oil stock peanuts.
- 5/ Cleaned and unshelled.
- 6/ Excludes peanuts milled for seed.
- 7/ Relates to oil mills only.
- 8/ All crushings regardless of grade.
