Peanut Stocks Down 2 Percent from Last Year

Peanut stocks reported in commercial storage on January 31, 2004 totaled 2.21 billion pounds of equivalent farmer stock, compared to 2.25 billion pounds last year. This total includes 1.51 billion pounds of actual farmer stock.

Shelled peanuts on hand totaled 647 million pounds of farmer stock equivalent. Roasting stock totaled 45.4 million pounds.

Shelled peanut stocks totaled 487 million pounds of which 471 million pounds were edible grades and 16.1 million pounds were oil stocks. Edible grade stocks by type included 72.4 million pounds of Virginias, 376 million pounds of Runners, and 22.4 million pounds of Spanish.

January **millings** totaled 437 million pounds. Millings by type were 66.7 million pounds of Virginias, 356 million pounds of Runners, and 14.9 million pounds of Spanish.

Commercial processors utilized 132 million pounds of **shelled edible** grade peanuts during January. Utilization by type was 70.2 million pounds for all peanut butter products, 28.5 million pounds for peanut candy, and 32.4 million pounds for snack peanuts. **Crushing** for oil and cake and meal totaled 41.7 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 2.85 million pounds of peanut butter.

Stocks of treated seed on hand January 31, 2004 totaled 1.11 million pounds, compared with 741,000 pounds on December 31, 2003. Of the January total, 193,000 pounds were Virginias and Valencias, and 910,000 pounds were Runners. December stocks of treated seed included 141,000 pounds of Virginias and Valencias, and 598,000 pounds of Runners.

Stocks estimates refer to January 31, 2004. All other data are for the month of January.
