## Shelled Edible Grade Season to Date Utilization Up 4 Percent from Last Year Peanut Stocks in Commercial Storage Totaled 2.80 Billion Pounds

**Peanut stocks** reported in commercial storage on April 30, 2010 totaled 2.80 billion pounds of equivalent farmer stock, compared with 3.09 billion pounds a year ago. This total includes 1.90 billion pounds of actual farmer stock.

**Shelled peanuts** on hand totaled 837 million pounds of farmer stock equivalent. Roasting stock totaled 56.3 million pounds.

Shelled peanut stocks totaled 630 million pounds of which 598 million pounds were edible grades and 31.2 million pounds were oil stocks. Edible grade stocks by type included 133 million pounds of Virginias and Valencias, 441 million pounds of Runners, and 24.4 million pounds of Spanish.

April **millings** totaled 377 million pounds. Millings by type were 58.0 million pounds of Virginias and Valencias, 315 million pounds of Runners, and 4.49 million pounds of Spanish.

Commercial processors utilized 150 million pounds of **shelled edible** grade peanuts during April. Utilization by type was 101 million pounds for all peanut butter products, 20.7 million pounds for peanut candy, and 27.1 million pounds for snack peanuts. **Crushing** for oil and cake and meal totaled 22.5 million pounds during the month.

Deliveries under the Government Domestic Feeding and Child Nutrition Programs amounted to 2.97 million pounds of peanut butter and 77,760 pounds of roasted peanuts during April.

**Stocks of treated seed** on hand April 30, 2010 totaled 38.8 million pounds, compared with 20.0 million pounds on March 31, 2010. Of the April total, 9.36 million pounds were Virginias and Valencias, 28.3 million pounds were Runners, and 1.14 million pounds were Spanish. March stocks of treated seed included 7.32 million pounds of Virginias and Valencias, 12.6 million pounds of Runners, and 87,000 pounds of Spanish.

Stocks estimates refer to April 30, 2010. All other data are for the month of April.
