

**PULLET CHICKS FOR BROILER
HATCHERY SUPPLY FLOCKS**

Domestic placements of pullet chicks for broiler hatchery supply flocks by leading primary breeders totaled 3,232,000 during October 1969, according to the Crop Reporting Board. This is 9 percent more than domestic placements in October 1968. Total placements (domestic plus exports) were reported at 3,678,000 compared with 3,414,000 a year earlier. Domestic placements of pullet chicks during January through October were 32,542,000, an increase of 6 percent from the same period last year.

The placement data include pullet chicks sold during the month, plus the number of pullet chicks expected from eggs sold during the preceding month. The primary breeders included in this report account for a very large percentage of total supply of replacement pullets for broiler hatchery supply flocks. Sales of replacement pullets by these breeders provide an indication of the potential number of pullets available for addition to hatchery egg supply flocks several months before the pullets will actually move into the flocks.
